GL2 9QH, Safran Landing Systems UK Ltd: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Safran Landing Systems UK Ltd. Please use the reference number below when making comments on this application.

- Permit Number: EPR/AP3433BQ/V004
- Regulated facility type: Surface treatment of metals, Section 2.3 Par A(1)(a), replacement of previous cadmium plating line with a Zinc/Nickel plating line in the same position in the Plating Shop (Surface Finishes). There will be the installation of a new dedicated effluent treatment plant, a new fume extraction system and amendments to the air emission release points.
- Regulated facility location: Safran Landing Systems UK Ltd, Cheltenham Road East, Gloucester, GL2 9QH
