# HD8 9QE, Clayton Hall Farm Bioenergy LLP: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Clayton Hall Farm Bioenergy LLP. Please use the reference number below when making comments on this application.

- Permit Number: EPR/FP3596EY/V003
- Regulated facility type: The applicant is applying to increase the throughput of their anaerobic digestion
  waste operation into an installation in response to biowaste treatment waste permit review. They intend to
  increase waste acceptance and treat up to 100,000 tonnes of waste per annum, extend the site boundary
  to include new silage clamp and solid biowaste storage and add a number of new waste codes. The site
  activity is Disposal of >50 T/D Non-Hazardous Waste (>100 T/d if only AD) Involving Biological Treatment –
  5.4 a(1) (a) (i)
- Regulated facility location: Clayton Hall Farm Bioenergy Plant, Clayton West, Huddersfield, West Yorkshire, HD8 9QE
