Hi Steve,

I have carried out an initial check of the application for Marsh House Farm and require additional information before I am able to duly make the application, as follows:

1. With reference to Table 1.19 (1.19.2) of [The Environment Agency \(Environmental Permitting and Abstraction Licensing\) \(England\) Charging Scheme 2022 \(publishing.service.gov.uk\)](https://publishing.service.gov.uk/government/uploads/system/uploads/attachment_data/file/103114/Environment-Agency-Environmental-Permitting-and-Abstraction-Licensing-England-Charging-Scheme-2022.pdf) a fixed charge of £779 is payable for a habitat assessment, as there is a Special Area of Conservation (SAC) within the screening distance. Please note that the additional fee must be paid in full before we can class the application as 'duly made'.
2. Please submit the data input files for the ammonia modelling.
3. Please confirm the location, number and size of the side fans on each of the poultry houses.
4. Please confirm the breakdown of bird numbers per house.
5. I have checked whether the farm is in a flood risk area and it is located within flood zone 3 (with a high probability of flooding from rivers and the sea). Please revise the accident risk assessment and accident management plan to consider the risks of pollution due to flooding.

Note: The accident risk assessment currently states 'Site located out of flood risk area'.

6. Please revise the accident risk assessment and accident management plan to include containment of firewater.
7. In accordance with your previous discussions with Kate Cummins with regards to proposed bespoke turkey emission factors, please provide further explanation/evidence as to the basis of the calculation for the bespoke emission factor that has been used in the modelling for the current turkey operations, in section 3.5 of the modelling report.
8. Please provide evidence of turkey placement dates and numbers for the current below threshold operation from the supplier.

Please send the information within 10 working days of this letter.

If we do not receive the information within 10 working days we will return your application.

If we do receive the requested information within 10 working days, we'll continue to check your application. We'll check to see if there's enough information for the application to be 'duly made'. Duly made means that we have all the information we need to begin determination. Determination is where we assess your application and decide if we can allow what you've asked for.

We'll let you know by letter whether your application can be duly made. If it can't be duly made, we'll return your application to you.

If we do have to return your application we'll send you a partial refund of your application payment. We'll retain 20% of the application charge to cover our costs in reviewing your application and requesting information. This maximum amount we'll retain is capped at £1,500.
