Unannounced inspection.

Present: redacted

A site induction was received form the well site supervisor and an inspection carried out.

An auger rig and associated plant and equipment were present on site. Well site supervisor daily report numbers 1 to 3 were inspected.

It was reported that auger drilling had reached 28m at 12:00 hrs today and a temporary 36" casing had been installed to 11m. It was reported that the rig was being changed over to reverse circulation operation in order to complete the conductor setting.

The open section of the site perimeter containment ditch was inspected. The water level in the ditch was low and the water was clear with no visible signs of contamination. The inlet end of the drainage ditch discharge pipe (leading to the interceptor) was above the water level and seen to be locked off. The main access chamber was seen to be locked off. Records relating to the lock off of the interceptor discharge outlet (to prevent discharge to watercourse) were inspected (management system document ref: RE-05-FO-039). The discharge outlet valve was recorded as verified locked off by a Rathlin Operations Engineer 09:33 hrs 07/01/2019.

Two bunded mobile fuel bowsers, a mobile compressor, two mobile lighting rigs and a generator were present on site. The site surface around the plant was inspected and no visible signs of contamination were seen.

Three visqueen lined open skips of clay arisings form the auger were present awaiting removal.

A daily environmental report check sheet is in use by the well site supervisor and records were inspected. Checks include:

Verification that interceptor valves are locked off

Perimeter containment ditch checks for leaks/damage, signs of oil/grease, water transparency, and presence of rats/mice etc.

Mud storage tanks & pipe work checks for damage/leaks

Waste storage tanks, containers and pipe work checks for damage/leaks

Diesel storage tanks, containers and pipe work checks for damage/leaks

Waste skips and bins checks for damage/leaks

On site odour check
