The document amends the Appendix 5 chemical inventory to include the Pure-bore additive for water based drilling muds (chemical constituent Carboxymethyl starch [non classified proprietary polysaccharide] CAS Number 9057-06-1). The document is agreed by the Environment Agency as a minor operational change to the operating techniques listed in Schedule 1 Table S1.2 of the environmental permit (permit condition 2.3.1).

A proposed amendment to the existing 'West Newton Well site Waste Management plan RE-05-EPRA-WN-WMP-005 Revision 2 dated 17/04/2014' was received from the operator 25/01/2019 in document reference: 'West Newton Well site 3rd Addendum to the Waste Management Plan Exploratory Operations RE-05-EPRA-WNWMP-005-Addendum 3 Rev: 2.00 dated 25/01/2019'.

The document amends the Appendix 5 chemical inventory to include calcium hydroxide (CAS Number 1305-62-0) and nut shells as additives for water based drilling muds. The document is agreed by the Environment Agency as a minor operational change to the operating techniques listed in Schedule 1 Table S1.2 of the environmental permit (permit condition 2.3.1).
