A proposed amendment to the existing 'West Newton Well site Waste Management plan RE-05-EPRA-WN-WMP-005 Revision 2 dated 17/04/2014' was received from the operator 15/03/2019 in document reference: 'West Newton Well site 4th Addendum to the Waste Management Plan Exploratory Operations RE-05-EPRA-WNWMP-005-Addendum 4 Rev: 2.00 dated 13/03/2019'.

Another proposed amendment to the existing 'West Newton Well site Waste Management plan RE-05-EPRA-WN-WMP-005 Revision 2 dated 17/04/2014' (superseding the 4th Addendum referred to above) was received from the operator 27/03/2019 in document reference: 'West Newton Well site 5th Addendum to the Waste Management Plan Exploratory Operations RE-05-EPRA-WNWMP-005-Addendum 5 Rev: 2.00 dated 27/03/2019'.

The 5th Addendum document amends the WNA-2 well cellar design and well construction proposals to align with those agreed by the Environment Agency in the WNA-2 WR11 application supporting statement RE-05-EPRA-WNA-2-WR11 Rev:2. It also amends the Appendix 5 chemical inventory to list additional drilling and cement additives for the proposed operations.

The document 'West Newton Well site 5th Addendum to the Waste Management Plan Exploratory Operations RE-05-EPRA-WNWMP-005-Addendum 5 Rev: 2.00 dated 27/03/2019', with the exception of the drilling additives Defoam Plus NS, Safe-Scav CA, FORM-A-BLOK and SI-414N listed in revised Appendix 5, is agreed by the Environment Agency as a minor operational change to the operating techniques listed in Schedule 1 Table S1.2 of the environmental permit (permit condition 2.3.1).

Document reference: 'West Newton Well site 5th Addendum to the Waste Management Plan Exploratory Operations RE-05-EPRA-WNWMP-005-Addendum 5 Rev: 2.00 dated 27/03/2019', with the exception of the drilling additives Defoam Plus NS, Safe-Scav CA, FORM-A-BLOK and SI-414N listed in revised Appendix 5, now forms part of the operating techniques required by the environmental permit (permit condition 2.3.1).

The drilling additives Defoam Plus NS, Safe-Scav CA, FORM-A-BLOK and SI-414N have been excluded from the approval because Environment Agency assessment of these products has not yet been completed.
