Audit of records in relation to testing of the WNA-2 well in August 2019

Well site supervisor daily reports were inspected. It was recorded that the WNA-2 well casing was perforated 21/08/2019.

Daily chemical inventories, Well site supervisor daily reports, the EXPRO well test event report, and delivery notes in relation to the storage and use of hydrochloric acid were inspected. Summary of findings: A total of 16m³ of hydrochloric acid 15% solution was delivered to site, 0.5m³ was used to pickle the coil, 11.5 m³ was used for one acid wash and squeeze, and the remaining unused 4m³ was removed from site after the well testing ceased.

Well site supervisor daily reports, the EXPRO well test event report, and the flare stack/incinerator operating temperature register RE-05-LOG-005 were inspected in relation to operation of the flares. Summary of findings: Only the CEB1200 unit was operated. Flare operating temperatures were logged on start-up and at 30 minute intervals during operation as required by the Rathlin Energy 'Recording Flare Stack Temperature Work Instruction' RE-04-020. All temperatures logged during operation were within the operating temperature range of the CEB1200 unit.
