Dear Harace,

Further to receiving your NDM letter I now reply with the required information. However, given the cost of the addition of AWCCT processing (£16,001) my client wishes to remove this from the variation process. We have ascertained today that this will be possible and so in the attached documents while reference is made to AWCCT treatment processes I would ask that you to ignore these elements. On this basis, a revised fee of £10622.00 will be sent under a separate cover.

In response to the requests made I attach:

- a revised fire prevention plan;
- a revised odour management plan;
- a revised dust management plan;
- a habitats assessment;
- a revised environmental risk assessment to accommodate a new energy assessment, raw material efficiency assessment and waste minimisation assessment;
- updated pre-acceptance and acceptance procedures; and
- a BAT assessment, including accommodation of changes under the waste treatment BREF and associated BAT conclusions.

In support of the above, I also attach a noise assessment survey and company environmental policy statement, while Technical Competence (Hazardous Waste Transfer and Treatment) will be provided by Ian Smith of Ian Smith Environmental Services.
