an existing farm going above 40000 EPR poultry place threshold. Specifically this is an egg laying poultry

farm. The two poultry houses provide a combined capacity for 72,000 egg layer places.

Regulated facility location: Wawne Hill Farm, Meaux Road, Hull, HU17 9SS
