#### The aim of this consultation is to ask whether you have any comments relevant to the permit application

(ii) only vegetable raw materials with a finished product production capacity greater than 300 tonnes per day or 600 tonnes per day where the installation operates for a period of no more than 90 consecutive days in any year; and Disposal, recovery or a mix of disposal and recovery of non-hazardous waste S5.4 Part A (1) (a) (ii) physio-chemical treatment.
- Regulated facility location: Aspall Cyder Ltd, Cyder House, Debenham, Suffolk, IP14 6PD
