L33 4YB, SIMONSWOOD PROPERTIES LIMITED: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for SIMONSWOOD PROPERTIES LIMITED. Please use the reference number below when making comments on this application.

- Permit Number: EPR/GB3805TM/V002
- Regulated facility type: This is a substantial variation to add a new activity 1.16.14 physical and chemical

treatment of waste. The activity is the treatment of construction and demolition waste by sorting, screening,

separation, crushing, compacting, blending and washing in a new wash plant. New EWC codes will be

added to the permit. The annual throughput will increase by 936,000 tonnes per year.

• Regulated facility location: Simonswood Aggregate Recycling Facility, Stopgate Lane, Knowsley, L33 4YB
