Dear Jeanette,

I write to thank you for all of the work that you have undertaken, working through the process of Duly Made in regard to this Permit Variation Application.

We appreciate that this application entails several activities, and appreciate that this may take additional resource to format the 'NEW' Permit especially as there are special rules with regard to the non-treatment of Hazardous Waste; and the cross over between Clinical Waste and Hazardous Waste.

During our communications in this regard, some decisions were made in order to provide clarity and expediency; and a numbering system was proposed so that the activities were labelled in a way that we could each refer to.

It appears that the reference numbers may have been re-allocated. The 'Manure storage Barn across the road' still features as AR2; but we have previously deleted that and provided new plans without that being included.

In this response, we have taken every effort to use the latest version of the Reference numbering that you have provided; except we have not used AR2.

We anticipate that the Permit will have numbers assigned as appropriate to the format.

#### **Permit Variation Fees Abatement**

It is quite possible that the aggregation of all of the individual fees entails some repetition of efforts and that the overall time required may not be as much as the sum of the fees would suggest. Therefore may we ask that when the Permit is formalised and Determined; an abatement review exercise is undertaken to check whether the Total Fee level reflects the overall time taken.

We now trust that you have all of the information in order to proceed with the Duly Making Review, but if not, then please phone me early on 27<sup>th</sup> August to ensure we fulfil all the requirements at this stage.
