As discussed earlier, a consultation response received on the Angus Fire application, EPR/XP3832NV/V004, expressed concern over their environmental record, particularly in the United States of America.

I have addressed concerns over their environmental record in the UK in the HPI Decision Document but have been advised I need to include further detail on their USA environmental record.

Are you able please to confirm:

- Under what legal entity does Angus Fire Limited operate in the USA? **Angus Fire Limited does not have a legal entity in the USA. However, it does have a sister company called National Foam Inc based in Angier, N. Carolina.**
- Is it the same legal entity as operates in the UK and is permitted at the High Bentham site. **No, a different legal entity.**
- How many sites does Angus Fire operate in the USA? **Angus Fire does not operate in the USA. National Foam has a fluorine free foam manufacturing site in Angier N. Carolina.**
- Are there any areas of environmental performance in Angus Fire's USA operations that have resulted in prosecutions, fines, regulatory intervention and/or non-compliance with any relevant environmental permits. **The short answer to all of these 'no' in relation to Angus Fire and 'no' in relation to National Foam.**
- Are there any outstanding regulatory investigations being carried out in relation to Angus Fire's environmental performance in the USA? **The answer is 'no' in relation to Angus Fire and 'no' in relation to National Foam.**
