LE10 3BY, Thistle Loos Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Thistle Loos Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/MP3027SL/A001
- Regulated facility type: Thistle Loos Limited are a provider of portable toilets throughout the UK, as a byproduct of the service, they are required to be cleared regularly. Thistle Loos Limited empties toilets utilising its own tankers and bringing the portable toilet waste back to their facility at Unit 21 Brindley Road, Dodwells Bridge Industrial Est, Hinckley, Leicestershire, LE10 3BY for further processing. The waste will be treated with the remaining liquid waste discharged to combined sewer, with consent from the relevant waste water provider. Collected waste will not typically be stored at the site as tankers will arrive at the site and directly discharge into the treatment plant.
- Regulated facility location: Thistle Loos Limited, Unit 21 Brindley Road, Hinckley, LE10 3BY
