LE14 3PR, Foyle Food Group Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Foyle Food Group Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/JP3025LZ/A001
- Regulated facility type: Application is for a New Bespoke permit for an existing abattoir. Activities at the site include the slaughter of cattle and the dressing, chilling and quartering of beef carcasses, the harvesting of offal, cod fat and the packing of beef offal and cod fat into vacuum pouches and lined cardboard boxes. No effluent treatment occurs at the site. Effluent is stored in the Effluent Storage Sump and the Truck-Wash Sump, which are emptied daily by road tanker for further treatment off-site. Il water is sourced from a mains supply, while the site contains a single hot water boiler. All waste is segregated on-site for removal to offsite waste facilities as appropriate. Air Emissions – the site has a single LPG fuelled boiler, located in the Boiler House, to supply hot water to the entire facility.
- Regulated facility location: Six Hills Abattoir - Foyle Meats, Melton Road, Six Hills, Melton Mowbray, Leicestershire, LE14 3PR
