Introduction

On 6 December 2024 this permit was varied and consolidated following the Food, Drink and Milk Industries sector permit review. An improvement programme was included – Table S1.3 comprising of 5 improvement conditions. This is a compliance assessment of IC10 and IC12.

Improvement Condition 10 relates to the provision of buffer storage at the Ashton Green Site. Documentation EPR CP 3430 WV – Bradgate Bakery – Ashton Green BAT Position on Buffer Storage, was provided on 21 February 2025. The operator committed to install an equalisation/balance tank of suitable size to provide capacity for 3 hours of maximum flow. The balance tank was fully constructed at the site inspection of 30 July 2025.

IC 10 can be considered complete.

Improvement Condition 12 required a risk assessment concerning possible soil and groundwater contamination from hazardous substances.

Documentation EPR CP3430 WV – Stage 1-3 Soil & Groundwater Contamination Risk Assessment, was also provided on 21 February 2025.

The risk assessment concluded that adequate pollution prevention measures and drains are fit for purpose in areas where hazardous substances are used and stored.

IC 12 can be considered complete.

Total non-compliance Score The total non-compliance score for this inspection is **0 CCS points**. The total CCS score for the year (2025) to date is 0, which puts you into the **Band A** compliance band and means that your subsistence fee is currently **95% of the charge for 2026**.
