Further to your email dated 3 March 2023 requesting further information in respect of Environmental Permit application reference EA/EPR/LB3701CX/A001 we provide below and attached the requested information. For clarity we have reproduced each of the points from your email in *blue italic text* and then provided our comments. For ease of reference we have numbered the points from 1 to 10.

1. Your application requires an assessment under the Habitats Regulations. The charge for this assessment is not included in your baseline application charge. You will therefore need to make an additional payment of £779.

We confirm that the additional payment of £779.00 was made to the Environment Agency by MJCA on behalf of Aggregate Industries Limited on 6 March 2023 using payment reference EPR\LB3701CX\A001

2. Form EPA, Part A, 7a, please provide a revised form with updated contact details.

Please find attached an updated version of Application Form Part A in which the contact details for Q7a have been updated.

3. Form EPA, Part A, 5c, please provide up to date details of current directors, Form EPA, Appendix 1, please provide up to date names and dates of births for directors. One of the directors has resigned and another director has been appointed.

Please find attached an updated version of Application Form Part A in which the details of the current directors at Aggregate Industries UK Limited have been updated to reflect the recent changes of directors since the application was submitted in March 2022.

5. Form EPB, Part B4, Table 1a please confirm treatment for disposal shall not exceed 50 tonnes per day, and 75 tonnes per day for recovery for slags and ashes as per section 5.4 of EPR Regulations.

Consistent with the pre-application advice received on 11 November 2021 and an email from Elizabeth Platts of the EA dated 15 November 2021 confirming that the facility will not comprise an installation, we confirm treatment for disposal shall not exceed 50 tonnes per day, and 75 tonnes per day for recovery for slags and ashes as per section 5.4 of EPR Regulations.

6. Form EPB, Part B4 section 1. please provide justification for wanting to accept EWC 19 08 99. If you want to accept any waste with a code ending in 99, you must provide more information and a full description of the waste in the document, (for example, detailing the source, nature and composition of the waste).

Aggregate Industries (AI) confirm that EWC 19 08 99 can be withdrawn from the application. Please find attached an updated version of Table 1 (Waste types to be accepted at Bardon Hill Quarry) from which EWC 19 08 99 has been removed.

7. Form EPF, Part F1, Table 2, the reference for the charging should be 1.16.12 physical treatment of non-hazardous waste, as you are not intending on chemical treatment.

We attach an updated version of Application Form Part F1. We note that in the pre-application advice, we were advised to specify activity reference 1.16.14 however, we confirm that Table 2 of the attached Form has been amended to specify activity reference 1.16.12.

8. Form EPF, Part F1, Table 3, please amend to include habitats assessment fee, also pay fee.

We confirm that Table 3 of the attached Application Form Part F1 has been amended to reflect this.

9. Form EPF, Part F1 has been signed by a signatory authorised by a Director who has since resigned. Can you please provide an up to date letter of authorisation from a current Director of the Company.
