## 1 INTRODUCTION

### 1.1 BACKGROUND

- 1.1.1 Crestwood Environmental Ltd ('Crestwood'), was commissioned by Shoby Poultry Partnership to undertake an Environmental Permit application for the expansion of the facility at Fosseway 775, Thrussington, Melton Mowbray, LE7 4TG ('the Site'). This document represents the accompanying Environmental Management System.
- 1.1.2 An EMS is a document required by a permit and a typical permit condition 1.1.1 states that, "The operator shall manage and operate the activities... in accordance with a written management system" and "records demonstrating compliance with rule 1.1.1 shall be maintained."
- 1.1.3 The complexity of an EMS is proportionate to the Proposed Development and the site specific EMS will be developed in accordance with the latest Environment Agency Guidance (available at <u>Develop a management system: environmental permits GOV.UK (www.gov.uk)</u> and <u>Intensive farming: comply with your environmental permit</u>).
- 1.1.4 The EMS will explain how S & L Hatcheries Ltd will manage their activities whilst minimising the risk to the environment. This document provides the proposed structure and summarises the content of the EMS.

  - (10) Site Closure



2	Maintenance Schedule and Records  Details of maintenance recommendations and records of all faults, maintenance work and inspections kept onsite.		
3	Incidents and Abnormal Operations  Identification of incidents and abnormal operations.		
5	Complaints Procedure	Methodology for dealing with a compliant including; records, investigation and action.	
6	Accident Prevention and Management Plan  A plan describing how to deal with incidents or events that have the potential pollute the environment or result in a non-compliance to the permit.  CE-FW-2414-RP04-ERA		
7	7 Training Roles and responsibilities of staff will be defined along with training and of contractors.		
8	8 Site Security The Site security onsite, including locked gates and signs.		
9	Review of Installation Plans	Details on reviews of all plans and how it is recorded.	
10	Changing Climate  Considerations of how a changing climate could affect installations or ability to comply with the permit.
