# LN8 2AP, Crockway Farms Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Crockway Farms Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/NP3231JC/V004
- Regulated facility type: Intensive Farming.
  - Change the permitted livestock from 8,000 production pigs >30kg to 13,000 production pigs >30kg.
  - Install a new slurry acidification unit to reduce ammonia emissions by 64%. Slurry will be collected in a newly constructed circular slurry store.
  - Surrender unused land to the south of the site.
- Regulated facility location: Caenby Cliff Farm, Caenby Corner, Market Rasen, Lincolnshire, LN8 2AP

#### **Non-Technical Summary**
