# ME2 4LY, Greenway Environmental Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

  at the Rochester Clinical Waste Treatment Facility to remove all the existing permitted activities and waste

  transfer and repackaging facility with container washing. The listed activities will fall under Section 5.3 of
  Schedule 1 to the Environmental Permitting regulations.
