MK7 7AJ, Intervet UK Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for **Intervet UK Limited**. Please use the reference number below when making comments on this application.

- Permit Number: EPR/UP3801PH/A001
- Regulated facility type: Installation, Activities being applied for at the site:
Section 4.5 “Pharmaceutical production”, Part (A) (1) (a). Producing pharmaceutical products (this is the main prescribed activity for the site); and
Section 5.4 “Disposal, recovery or a mix of disposal and recovery of non-hazardous waste”, Part (A) (1) (a). Disposal of non-hazardous waste with a capacity exceeding 50 tonnes per day (or 100 tonnes per day if the only waste treatment activity is anaerobic digestion) involving one or more of the following activities (ii) physico-chemical treatment (this is a technically connected associated activity related to the pH correction / treatment of waste water prior to discharge of up to 300m3 per day to sewer).
The operator is applying to vary the current permit to incorporate a revised waste acceptance criteria for waste being imported for disposal at the site.
- Regulated facility location: MSD Animal Health (Milton Keynes), Walton Manor, Walton, Milton Keynes, Buckinghamshire, MK7 7AJ
