

## About this consultation

### NE63 9XS, SUEZ Recycling and Recovery UK Ltd: environmental permit consultation

**The aim of this consultation is to ask whether you have any comments relevant to the permit application**

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for SUEZ Recycling and Recovery UK Ltd. Please use the reference number below when making comments on this application.

- Permit Number: EPR/UP3494ZL/V007
- Regulated facility type: Operator is seeking to vary the environmental permit to remove the IVC activity and allow the operation of an Anaerobic Digestion (AD) plant to process food waste from household waste collections as well as industrial and commercial customers. The process will generate biogas which then ultimately feeds into a biogas upgrading plant to National Gas Grid criteria and injected into the gas grid. Alternatively, the biogas may be processed by a Combined Heat and Power (CHP) engine to generate heat and electricity that would be used by the AD plant.
- Regulated facility location: Ellington Road Composting Facility, Ellington Road, Newmoor, Ashington, Northumberland, NE63 9XS
