NG5 8PZ, Mick George Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Mick George Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/KB3109GZ/A001
- Regulated facility type: This is a bespoke application for a new inert landfill, adjacent to an existing non-hazardous landfill and within a clay quarry. Under the proposals, 375,000 m3 of inert waste will be deposited at the site to enable restoration of part of the quarry. When using a bulk conversion factor of 1.7 tonnes per m3 this equates to 637,500 tonnes. It is proposed that a maximum of 450,000 tonnes of material would be imported to the site per annum.
- Regulated facility location: Dorket Head Inert Site, Woodborough Lane, Nottingham, Nottinghamshire, NG5 8PZ
