# NN7 2QF, Acorn Bioenergy Operations Limited: environmental permit consultation

#### The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Acorn Bioenergy Operations Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/RP3426SN/A001
- Regulated facility type: Section 5.4 (a)(i) and (b)(i) non-hazardous waste installation biological treatment activity. The site will be operating an anaerobic digestion facility with biogas being burned in Combined Heat and Power engines/boilers with the energy being used to fuel the site
- Regulated facility location: Horse Close Anaerobic Digester, Courteenhall, Quinton, Northamptonshire, NN7 2QF
