Thank you for your time the other day.

Based on our conversations 11/06/2025 please refer below for the activities to be applied for and base charges.

### **Looking at Option B:**

Shredding of Li batteries and the additional waste listed in your letter dated Jan 2025 and the subsequent treatment of the shred to recover the metals, plastics and black mass.

- Shredding of non-hazardous wastes, including Li batteries and the other non-hazardous wastes DAA or 5.4 if it exceeds 75 tonnes per day (£12,357). Based on our conversations, this will be a DAA and as a consequence you are proposing to limit the tonnage of this operation (and AR1 open windrow composting and AR2 ash and slag) to less than 75 tonnes per day as discussed 11/06/2025, thus no charge.
- Shredding of hazardous wastes over 10 tonnes per day as discussed, then 5.3 Part A a) ii) activity (£16,001), includes the continuous treatment of the residual waste to separate out recyclables (including battery waste from SUEZ sister sites, i.e. the introduction of pre-shredded battery waste into the process after the shredder would not "break" the continuous nature of the process and mean that an additional activity would not be required in the permit). The storage/handling of the shredded material prior to treatment and how the material would be safely introduced into the plant, specifically regarding the potential fire risk and risk of fugitive emissions (e.g. dust, VOCs (residual solvents/electrolyte)) would need to be fully considered/assessed in the application.
- Storage of hazardous wastes (more than 50 tonnes at any one time) pending treatment on site or transfer off site to a third party is a 5.6 activity (£13,519). **OR** if less than 50 tonnes then the hazardous waste pending treatment on site is a DAA and the hazardous waste for transfer is a variation to the waste operation to become a hazardous waste transfer station (waste operation) (£7,969).
- Addition of non—hazardous waste for transfer minor variation (£2,753) of existing non-hazardous waste treatment and transfer facility if the hazardous waste falls under a 5.6 activity **OR** included in the variation to become a hazardous waste transfer station (waste operation, refer to bullet point 3 above).
- (Plus FPP management plan & fee, and habitats charge)
