Sorry we got cut off, I was out of the office and clearly not enough signal.

I have had a look back and I can't see where I have got the reference to cement storage for HBM in a Permit. In any event I think that we'd be happy if, as it doesn't form any part of the waste management activity, and we got it permitted separately by the Local Authority who normally deal with Part Bs.

I was also reminded in looking back at past IBA plants I have sought permits for, that the Day Group's IBA facility at Murphy's Wharf, Greenwich simply includes reference to HBM in the introduction, but the cement storage isn't listed on that Permit, and there are no conditions relative to HBM plan or cement storage.

Additionally at their Salfords site, (which isn't operational yet) there is planning permission for the HBM operation, but it wasn't even referenced on the permit.

I also attach their Avonmouth IBA Permit, which doesn't include a HBM operation, and there isn't one there, but include it for reference as it's operations are identical to those at Wellingborough. The layout of the plant is slightly different simply to fit on the sites, but the Permitted activities are the same.
