We need to ask you for some missing information and additional fees before we can do any more work on your application. Please provide us with more information and payment as follows:

- 1. **Company Secretary** we now require the email of the Company Secretary (we have the phone number for Mark Wannell), please provide this. *Our application forms do not ask for this currently, they will need to be amended.*
- 2. Additional fees you have paid the substantial variation fee of £7218, however

- we also require the additional fees for for the habitats assessment £779), audit of the ammonia detailed modelling (£620) and assessment of the dust and bioaerosol management plan (£620), so the total required to be paid is £2019.
- 3. **Installation name** the current permit is for Brookside Farm Poultry Unit, but the application form C3.5 section 1a names it Brookside Poultry Unit. Please confirm which name you want the installation to be called.
- 4. **Ammonia modelling files** please submit the electronic data input files for the detailed ammonia modelling report. *Please note, the current permit is for* 106,155 turkeys, not 106,000, however as the baseline (existing) scenario has been modelled for the lower amount, this is the lower (precautionary) baseline so we don't need this changing. See attached variation notice and consolidated permit issued in 2014 which hasn't been changed in subsequent transfers or the permit review.
- 5. **Ventilation** the pre-application screening and ammonia modelling was completed using high velocity fans with an efflux velocity of 11m/s, but it states in the non-technical summary that the velocity is 9m/s. Please confirm the latter is a typo and the fans will be operated at 11m/s.
- 6. **Standby generator(s)** in the technical standards it states there are two standby generators in the emission point table, but then states there is one at the end (0.78MWth thermal input). There also appears to be two on the site drainage plan submitted with the application. Please confirm which is correct and provide the thermal input capacity of the second if there are two.
- 7. **Biomass boilers** in the technical standards it states the heating will be by LPG and biomass boilers. Please confirm these will be the same as already permitted (five biomass boilers, each with a thermal input capacity of 0.215MWth). It is not clear how many biomass boilers there are from the housing and drainage plan as there are several grey rectangles indicated on the plan. If there are more than the original 5 please provide details of how many, the grid location of their stacks, and each individual thermal input capacity in MWth. Please note I may need to ask for further information if these have changed from the current permit in order to complete a further assessment, please refer to guidance on biomass boilers: Intensive farming risk assessment for your environmental permit GOV.UK
- 8. **Housing and drainage plan** please submit a revise plan indicating the locations of the biomass boilers in a different colour to grey so we can clearly see which they are. Please also confirm what the orange rectangles are, located between the houses, e.g. between H4 and H5 (there are several more). Please see the attached variation notice and consolidated permit issued in 2014, which provides the locations of the biomass boilers in the current permit. In addition, please include the pathway of lightly contaminated yard water in the revised plan, as it only appears to show the clean and dirty water pathways. It is likely we will need further details for the drainage system during

determination, such as whether the attenuation ditch is blocked off to allow settlement/soakaway and whether there are overflow outlets from both ((e.g. D4 is from one?) and where this/these ultimately drain to, such as a named river, along with where D1 – D3 outlets drain to. In addition, the environmental risk assessment for fire wash water mentions a clean water lagoon, which doesn't appear to be on the current drainage plan. You may wish to provide more detail at this stage, otherwise the determination officer will ask for further details.

You must send us the information and payment by 24/07/2025, but please note I will be on leave 25/07/2025 - 04/08/2025 (inclusive), and then only in the office one day the following week (Tuesday 05/08/2025), so if you could respond as soon as possible, and ideally no later than **22/07/2025**, that would be greatly appreciated to enable this application to progress as quickly as possible.

If we do not receive this by the deadline of 24/07/2025 we will return your application. If we receive what is missing by the deadline, we will continue to check your application. We'll check to see if there's enough information for the application to be 'duly made'. Duly made means that we have all the information we need to begin determination.
