

## About this consultation

### NR30 3QD, Veolia ES (UK) Limited: environmental permit consultation

**The aim of this consultation is to ask whether you have any comments relevant to the permit application**

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Veolia ES (UK) Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/BB3808TU/V004
- Regulated facility type: S5.3 A(1)(a)(iv) – the disposal or recovery of hazardous waste with a capacity exceeding 10 tonnes per day involving repackaging. This relates to the removal of oils and other hazardous materials from the structures and vessels, and repackaging the materials into barrels, IBCs and other containers.

S5.6 Part A(1)(a) – the temporary storage of hazardous waste with a total capacity exceeding 50 tonnes. This relates to the temporary storage of hazardous materials removed from the structures and vessels prior to the hazardous materials being removed off-site.

Waste operations include the manual dismantling of the vessels and structures using the techniques of manual sorting, manual separation, hot and cold cutting, shredding, hydraulic sheering and power sawing.

- Regulated facility location: Great Yarmouth Decommissioning Facility, South Beach Parade, Great Yarmouth, Norfolk, NR30 3QD

Providing a business can prove that the proposed activities meets all the legal requirements, including environmental, technological and health requirements, then we are legally obliged to issue a permit, even if some people do not approve of the decision.
