NR31 0LS, East Coast Waste Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for East Coast Waste Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/GB3009GG
- Regulated facility type: This is a variation from a Standard Rules permit (SR2008 No3 75kte household,

commercial and industrial waste transfer station with treatment) to a Bespoke waste permit. The site

boundary is being extended by a small amount, which brings the site closer to sensitive receptors, which

means they can no longer meet the standard rules. There will be no change to the site layout, activities on

site or tonnages.
