# NR31 0LS, East Coast Waste Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for East Coast Waste Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/KP3425SU/A001
- Regulated facility type: A new bespoke permit for the crushing and grading of construction and demolition
  waste and the shredding of waste wood.

Accepting 75,000 tons per annum of construction and demolition waste and 30,000 tons per annum of waste wood.

Construction and demolition waste will be crushed and graded within a high bunded area. Wood waste will be stored in concrete fire bays before being put into a wood shredded. No other wastes will be accepted or treated at the site.
