OX29 0SZ, Ubico Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Ubico Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/FB3602KK
- Regulated facility type: The site currently runs under the listed standard rules and exemptions; SR2022 No7 – Material Waste Facility, S1 Exemption – Storing waste in secure container and S2 Exemption – Storing waste at a secure site. The site will carry out the same operations (the storage and distribution of outgoing waste materials), however owing to the forthcoming 2026 changes to exemptions, a variation to a bespoke permit is required.

The site operates as a recycling bulking facility, authorising the manual sorting, separation and subsequent storage of permitted wastes for onward transfer. The site currently handles predominately non-hazardous waste and some hazardous waste.

- Regulated facility location: West Oxfordshire Waste Transfer Station, Downs Road, Witney, OX29 0SZ
