### OX29 4ES, Hanson Quarry Products Europe Limited: environmental permit consultation

- Regulated facility type: The application is for an Aggregates Recycling Facility and a deposit for recovery activity for the treatment of waste to produce soil, soil substitutes and secondary aggregates to be imported off site for sale/onwards dispatch and the processed soils will be used for restoration infill at the site to restore the quarry.
- Regulated facility location: Hanson Aggregates Cassington Quarry, Cassington, OX29 4ES
