

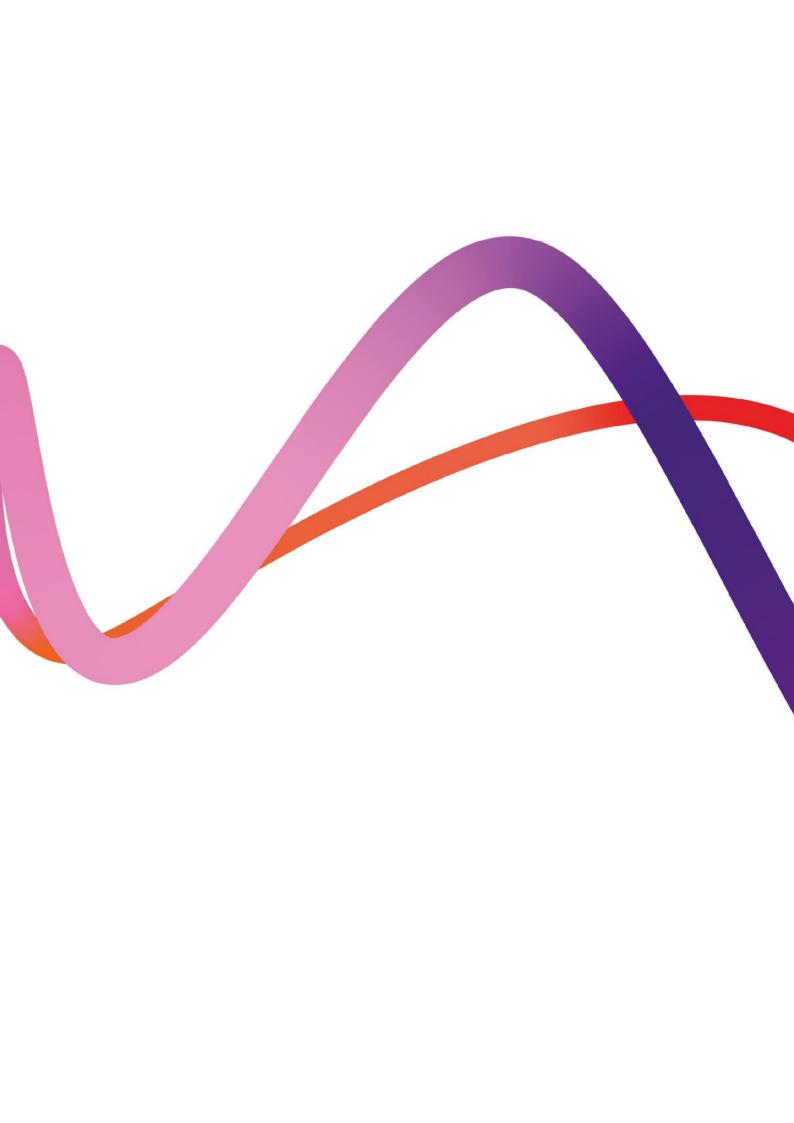



Executive Summary

An archaeological desk study has been completed to cover the following elements of the Proposed Development:

- EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections; and
- Grid Connection.

This has involved a review of existing data bases including the Cambridgeshire and Norfolk Historic Environment Records, as well as primary sources such as historic maps and LiDAR data. Based on this data, an assessment has been completed for the potential for the site of the Proposed Development to contain remains of archaeological interest.

The EfW CHP Facility Site is presently used as an aggregates yard and storage warehouse with hardstanding whilst the site of the TCC is located in grassland flanked by field boundary ditches on the north, east west and south-east. This area was used for agricultural purposes during the 19th century as part of Great Boleness Field. Historic mapping from the later 19th century shows the area as comprising small regular marked by frequent land drains. From the start of the 20th century it was increasingly used as an area of orchards and market gardens.

Previous investigation in the area have identified Romano-British remains representing agricultural use as well as potentially occupation and based on this, the potential for the presence of Roman period remains in the construction compound area is considered to be medium.

A review of borehole records from within the EfW CHP Facility site has identified bands of peaty material, which are likely to derive from a freshwater marsh deposit. These interface with deposits of yellow sandy and silty clays, which may be estuarine in origin. These earlier deposits lie directly below modern made ground deposits with a depth of around 0.6m to a maximum of 2m which appear to derive from the construction and use of the existing aggregates yard.

The Grid Connection is proposed to comprise an underground cable to be installed below the road surface and along the road verge of the A47. Previous archaeological investigations, including fieldwalking and observations made before and during construction of the A47 have identified artefactual and other evidence for previous use and occupation of the area. These include evidence for Romano-British settlement and agricultural activity and medieval as well as post-medieval agriculture. Historic maps also show the presence of industrial and transport infrastructure in the 18th and 19th centuries, including a canal, railways and a brickworks.

1. Introduction

1.1 Background

- Medworth CHP Limited (the Applicant) is applying to the Secretary of State for a Development Consent Order (DCO) to construct operate and maintain an Energy from Waste (EfW) Combined Heat and Power (CHP) Facility on the industrial estate, Algores Way, Wisbech, Cambridgeshire. Together with associated Grid Connection, CHP Connection, Water Connections, and Temporary Construction Compound (TCC), these works are the Proposed Development.
- The Proposed Development would recover useful energy in the form of electricity and steam from over half a million tonnes of non-recyclable (residual), non-hazardous municipal, commercial and industrial waste each year. The Proposed Development has a generating capacity of over 50 megawatts and the electricity would be exported to the grid. The Proposed Development would also have the capability to export steam and electricity to users on the surrounding industrial estate.
- The Proposed Development is a Nationally Significant Infrastructure Project (NSIP) under Part 3 Section 14 of the Planning Act 2008 (2008 Act) by virtue of the fact that the generating station is located in England and has a generating capacity of over 50 megawatts (section 15(2) of the 2008 Act). It, therefore, requires an application for a DCO to be submitted to the Planning Inspectorate (PINS) under the 2008 Act. PINS will examine the application for the Proposed Development and make a recommendation to the Secretary of State (SoS) for Business, Energy and Industrial Strategy (BEIS) to grant or refuse consent. On receipt of the report and recommendation from PINS, the SoS will then make the final decision on whether to grant the Medworth EfW CHP Facility DCO.

1.2 The Applicant and the project team

- The Applicant is a wholly owned subsidiary of MVV Environment Limited (MVV). MVV is part of the MVV Energie AG group of companies. MVV Energie AG is one of Germany's leading energy companies, employing approx. 6,500 people with assets of around €5 billion and annual sales of around €4.1 billion. The Proposed Development represents an investment of approximately £450m.
- The company has over 50-years' experience in constructing, operating, and maintaining EfW CHP facilities in Germany and the UK. MVV Energie's portfolio includes a 700,000 tonnes per annum residual EfW CHP facility in Mannheim, Germany.
- MVV Energie has a growth strategy to be carbon neutral by 2040 and thereafter carbon negative, i.e., climate positive. Specifically, MVV Energie intends to:
 - reduce its direct carbon dioxide (CO₂) emissions by over 80% by 2030 compared to 2018;

Since 2015, this modern and efficient facility has been using around 265,000 tonnes of municipal, commercial and industrial residual waste per year to generate electricity and heat, notably for Her Majesty's Naval Base Devonport in Plymouth, and exporting electricity to the grid.
- In Dundee, MVV has taken over the existing Baldovie EfW Facility and has developed a new, modern facility alongside the existing facility. Operating from 2021, it uses up to 220,000 tonnes of municipal, commercial and industrial waste each year as fuel for the generation of usable energy.
- Biomass is another key focus of MVV's activities in the UK market. The biomass power plant at Ridham Dock, Kent, uses up to 195,000 tonnes of waste and non-recyclable wood per year to generate green electricity and is capable of exporting heat.
- To prepare the ES for the Proposed Development, the Applicant has engaged Wood Group UK Limited (Wood). Wood is registered with the Institute of Environmental Management and Assessment (IEMA)'s Environmental Impact Assessment (EIA) Quality Mark scheme. The scheme allows organisations that lead the co-ordination of EIAs in the UK to make a commitment to excellence in their EIA activities and have this commitment independently reviewed.

1.3 The Proposed Development

- 1.3.1 The Proposed Development comprises the following key elements:
 - The EfW CHP Facility;
 - CHP Connection;
 - Temporary Construction Compound (TCC);
 - Access Improvements;
 - Water Connections; and
 - Grid Connection.
- A summary description of each Proposed Development element is provided below. A more detailed description is provided in **ES Chapter 3: Description of the Proposed Development (Volume 6.2)** of the ES. A list of terms and abbreviations can be found in **Chapter 1 Introduction, Appendix 1F Terms and Abbreviations (Volume 6.4)**.



- EfW CHP Facility Site: A site of approximately 5.3ha located south-west of Wisbech, located within the administrative areas of Fenland District Council and Cambridgeshire County Council. The main buildings of the EfW CHP Facility would be located in the area to the north of the Hundred of Wisbech Internal Drainage Board (HWIDB) drain bisecting the site and would house many development elements including the tipping hall, waste bunkers, boiler house, turbine hall, air cooled condenser, air pollution control building, chimneys and administration building. The gatehouse, weighbridges, 132kV switching compound and laydown maintenance area would be located in the southern section of the EfW CHP Facility site.
- CHP Connection: The EfW CHP Facility would be designed to allow the export
 of steam and electricity from the facility to surrounding business users via
 dedicated pipelines and private wire cables located along the disused March to
 Wisbech railway. The pipeline and cables would be located on a raised, steel
 structure.
- TCC: Located adjacent to the EfW CHP Facility Site, the compound would be used to support the construction of the Proposed Development. The compound would be in place for the duration of construction.
- Access Improvements: includes access improvements on New Bridge Lane (road widening and site access) and Algores Way (relocation of site access 20m to the south).
- Water Connections: A new water main connecting the EfW CHP Facility into the local network will run underground from the EfW CHP Facility Site along New Bridge Lane before crossing underneath the A47 (open cut trenching or horizontal directional drilling (HDD)) to join an existing Anglian Water main. An additional foul sewer connection is required to an existing pumping station operated by Anglian Water located to the northeast of the Algores Way site entrance and into the EfW CHP Facility Site.
- Grid Connection: This comprises a 132kV electrical connection using underground cables. The Grid Connection route begins at the 132kV switching compound in the EfW CHP Facility Site and runs underneath New Bridge Lane, before heading north within the verge of the A47 to the Walsoken Substation on Broadend Road. From this point the cable would be connected underground to the Walsoken DNO Substation.

1.4 Purpose of this report

- This report comprises a desk study and has been prepared to provide details on the known historic environment baseline for the Study Area, extending from 2km from the Order limits.
- The report is intended to inform the identification and assessment of potential impacts of the proposed development, the scope of further survey and intrusive investigations, and requirement for potential mitigation, the conclusions for which are set out in **Chapter 10 Historic Environment (Volume 6.2)**.

2. Methodology

2.1 General

- The EfW CHP Facility Site currently comprises an existing waste and aggregates recycling and waste transfer station (WTS) with adjacent hard standing, with adjoining grassed areas which would be used during construction (TCC). In addition, the Proposed Development will include Combined Heat and Power (CHP), Access Improvements, Water Connections and a Grid Connection. This baseline report therefore covers the following elements of the proposed development:
 - EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections; and
 - Grid Connection.
- Searches of the Cambridgeshire and Norfolk Historic Environment Records (CHER and NHER) for non-designated assets were undertaken for a Study Area extending 1km from the Order limits. Data on designated heritage assets from Historic England's National Heritage List England online (NHLE) was obtained covering a Study Area of 2km from the Order limits. The records are set out within **Appendix 10.A (Volume 6.4)**.
- Information about previous archaeological investigations/events was obtained from CHER and NHER. These are detailed in the report and are presented in the Archaeological Events Gazetteer (**Appendix 10.A, Volume 6.4**). Details of findspots recorded as part of the Portable Antiquities Scheme (PAS) were received from CHER and NHER. However, due to the confidential nature of these records only generalisations can be included within this DBA.
- Searches of relevant archaeological and cartographic material as well as secondary historical sources were undertaken.
- This assessment has been undertaken in accordance with guidelines set out by the Chartered Institute for Archaeologists "Standard and Guidance for Archaeological Desk-Based Assessment" (CIfA, 2017).

2.2 Aim and Objectives

- The aim of this desk study is to identify and characterise the historic environment (archaeological, historic and built heritage) resource within the Order limits and surrounding Study Areas, in order to provide an archaeological and historical baseline for the proposed development options.
- The objectives of this desk study are to:
 - Identify and describe designated any undesignated built heritage assets within the Order limits and Study Areas;

- Identify and describe historic landscape features within the Order limits;
- Assess the potential for previously unrecorded archaeological remains within the Order limits; and
- Identify areas of previous disturbance that may have removed archaeological remains from the Order limits.

2.3 Data Gathering Methodology

- The following baseline data sources have been consulted:
 - National and county-based registers of known archaeological and historical sites;
 - Cartographic and historic documents;
 - Place and field-name evidence;
 - Aerial photographs and National Mapping Programme data;
 - LiDAR data;
 - Historic maps data; and
 - Published secondary historical and archaeological information.
- These were obtained from the following organisations:
 - Cambridgeshire and Norfolk Historic Environment Records (CHER and NHER);
 - The Environment Agency (LiDAR);
 - National Archives, via thegenealogist.com;
 - Archaeology Data Service;
 - Historic England via Britain from Above and Cambridge University Collection of Aerial Photography (CUCAP);
 - National Library of Scotland Historic Mapping Collection; and
 - Wood Plc library and other, web-based published material.
- The assistance of these bodies and their staff is gratefully acknowledged.
- The data provided by the HER include data for several different aspects of the historic environment including known surviving assets, records of former structures or sites found through documentary evidence and findspots of artefacts. Due to the range of data included within the HER these records must be considered, not only for their historical value but also for their archaeological potential. Many former assets may have already been entirely removed; findspots may indicate former activity but are not, in themselves, evidence for buried archaeological remains. This consideration also takes into account any former archaeological events that may have occurred within the Study Area, for example archaeological monitoring or excavation, the data for which is also provided within the HER dataset. Where these

previous events are pertinent to the Order limits they have been discussed within the *Archaeological and Historical Background*.

2.4 Site walkover

- A site walkover was conducted in April 2021. This comprised a visual inspection of the land within the Order limits, making a photographic record of existing land conditions and development. The aim was to make observations on the presence and condition of known or as yet known heritage assets within the Order limits, as well as to highlight areas of pre-existing impact and as such, assess the potential survival for the below ground archaeological resource.
- Observations made during the site walkover have been incorporated into the following baseline within this report.

2.5 Assessment of Archaeological Potential

- 2.5.1 Professional judgement has been used to assign a level of potential for land within the Order limits to contain as yet unknown below ground archaeological remains according to the system described below.
 - High There is recorded evidence that archaeological features and finds of this
 period are likely to be represented in the Order limits;
 - Medium Recovery of material, or observations of activity in the Study Area suggests that archaeological features and finds of this period may be represented in the Order limits; and
 - **Low** There is no evidence which suggests that archaeological features and finds of this period are likely to be represented in the Order limits.
- Where a general potential for the presence of archaeological features is identified, but there is insufficient information available to make an informed judgement on the likely significance of any features which may be present, a rating of **Unknown** has been used.
- The results of this exercise are presented within the relevant chronological subsections in **Section 5**.

2.6 Heritage Significance

- The significance of heritage assets is based on professional judgement as informed by relevant guidance (Historic England 2008 and 2015) and NPS EN-1 (Department of Energy and Climate Change 2011).
- 'Significance' in terms of heritage-related planning policy is defined as the value of a heritage asset to this and future generations because of its historic, archaeological, architectural, or artistic interest. Significance derives not only from a heritage asset's physical presence, but also from its setting.

- Historic interest An interest in past lives and events (including pre-historic). Heritage assets can illustrate or be associated with them. Heritage assets with historic interest not only provide a material record of our nation's history but can also provide meaning for communities derived from their collective experience of a place and can symbolise wider values such as faith and cultural identity.
- Archaeological interest There will be archaeological interest in a heritage asset if it holds, or potentially holds, evidence of past human activity worthy of expert investigation at some point.
- Architectural and artistic interest These are interests in the design and general aesthetics of a place. They can arise from conscious design or fortuitously from the way the heritage asset has evolved. More specifically, architectural interest is an interest in the art or science of the design, construction, craftsmanship and decoration of buildings and structures of all types. Artistic interest is an interest in other human creative skill, like sculpture.

2.7 Limitations and Assumptions

- The data in the records supplied by Cambridgeshire HER is drawn from a variety of sources, which have variable precision and accuracy. Some records are based on recent professional archaeological investigations, which adhere to CIfA standards, whilst others are based on older records or are reliant on reporting by members of the public; the precision of these records cannot always be reliably assessed. Information on individual records is précised from the detailed description sheets provided by CHER, supplemented by information gathered during the research for the DBA as appropriate.
- Each of the consulted data sources represents a collection of existing knowledge and is unlikely to be a complete record of all surviving heritage features. The data held by Cambridgeshire HER is constantly updated to include new survey results. It should also be noted that both national and local records of the historic environment relate to known heritage sites and archaeological finds. Limited available data may reflect a lack of research, especially if there has been little or no previous development activity, or methodological limitations (as in the case of aerial survey) rather than an absence of archaeological evidence itself.



3. Location, Geology and Land Use

3.1 Location and landscape context

EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections

- The EfW CHP Facility Site includes an existing Waste Transfer Station and an aggregates supply yard, the WTS. The EfW CHP Facility Site is located on the edge of an existing industrial estate and is currently accessed via Algores Way. The EfW CHP Facility Site includes steel framed storage-type buildings but the majority of the Site is predominantly compacted ground, and the soil has been scraped back from the working area to form perimeter bunds. The bunds are present along the whole length of the southern and western borders and the southern half of the eastern boundary. The WTS was built in the early 2000s, with the site having previously been occupied by pastoral land as part of Great Boleness Field.
- The EfW CHP Facility Site is bordered to the west by the disused March to Wisbech Railway, the route of which includes the old railway line track bed and is heavily overgrown with vegetation.
- The Access Improvements will be along New Bridge Lane, an existing narrow road and the TCC will be within two areas of lined demarcated by IDB ditches south of the EfW CHP Facility Site.

Grid Connection

The Grid Connection passes within the highway (New Bridge Lane and Broadend Road) or within the highway verge (A47). Land surrounding but excluded from the Grid Connection includes enclosed fields in arable and orchard use which are marked by regular land drainage ditches serving as field boundaries.

3.2 Historic Landscape Character

The Grid Connection route largely follows the A47 which largely bisects agricultural land and much of this is identified in the Norfolk Historic Landscape Characterisation as 20th century agriculture. This comprises fields whose current size and form is a result of the loss of earlier field boundaries. Other field forms which are present are 18th-19th century enclosure, derived from both piecemeal and parliamentary enclosure and horticulture, which is predominantly orchards.

3.3 Geology and soils

EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections

- The land within the Order limits is situated upon bedrock geology comprising Ampthill Clay Mudstone. This is a sedimentary bedrock formed between 164 and 157 million years ago during the Jurassic period.
- The entirety of the Proposed Development area is underlain by tidal flat deposits. These are superficial deposits of clay and silt formed up to 2 million years ago, in a local environment dominated by shorelines. The drift geological profile of the region is characterised by a series of silts and clays, with most Romano-British and medieval archaeological features known present in an upper silt deposit (Hall 1996).
- The soils in this area comprise loamy and clayey soils of coastal flats with naturally high groundwater, ranking at moderate fertility on Soilscape (Landis 2020).

Grid Connection

The entirety of the Grid Connection is located within tidal flats around Wisbech and The Wash where deposit sequences extend to depths in excess of 20m. Historic land-surfaces may be present within deep silt sequences and could contain sensitive and significant heritage assets relating to archaeological activity from different periods throughout the Holocene.



4. Archaeological and Historical Background

- This section provides a high-level overview of the type and distribution of known heritage assets within the Order limits and Study Area. Details of these are incorporated onto a period-based chronology of the Order limits in **Section 4.7**.
- Reference numbers for designated assets and for Cambridge Historic Environment Record (CHER) and Norfolk Historic Environment Record (NHER) entries are provided in brackets and these are listed in **Appendix 10A**.

4.2 Designated heritage assets

- These assets have statutory protection. Designated heritage assets within the Order limits and 2km Study Area are listed in **Appendix 10.A** and their locations shown on **Figure 10.1**. Within the 2km Study Area there are:
 - 3 conservation areas;
 - 1 registered park and garden;
 - 317 listed buildings; and
 - 3 scheduled monuments.
- There are no World Heritage Sites or Registered Battlefields within the 2km Study Area.
- Further detail is provided below for the designated heritage assets within the 2km Study Areas for the EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections, and for the Grid Connection separately.

EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections

Site

There are no designated heritage assets within the Order limits for the EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections.

Study Area

- Within the 2km Study Area for the EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections there are (listed in **Appendix 10.A**):
 - 3 conservation areas;
 - 1 registered park and garden;
 - 286 listed buildings; and

- 2 Scheduled monuments.
- There are no world heritage sites, registered battlefields, protected wreck sites or protected military sites within the Study Area.

Conservation Areas

- The following are located within the 2km Study Area for the EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections:
 - Wisbech Conservation Area;
 - Bowthorpe Conservation Area; and
 - Elm Conservation Area.
- Wisbech Conservation Area was designated in March 1971 and comprises much of the town centre as well as extending along The Brinks. Bowthorpe Conservation Area is located north-east of Wisbech town centre and includes Wisbech Park and adjoining residential land. Elm Conservation Area comprises the historic core of the village of Elm and was designated in 1976.

Registered Park and Garden

Peckover House Grade II Registered Park and Garden (List entry no. 1000629) is located on North Brink and comprises a largely 19th century enclosed garden attached to an 18th century house which faces on to North Brink.

Listed Buildings

There are 286 listed buildings within the 2km Study Area for the EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections, with the great majority of these within Wisbech Conservation Area. Many of these are approximately 1.5km north of the EfW CHP Facility Site, though listed buildings along North Brink are within approximately 1.1 km to the north. Only one of the listed buildings is within 1km of the of the EfW CHP Facility Site, which is the Grade II listed Albion Villa (List entry no. 1229758), located approximately 830m to the north. There are also listed buildings within the village of Elm, approximately 1.6km to the south-east of the EfW CHP Facility Site.

Scheduled monuments

- There are two scheduled monuments within the 2km Study Area for the EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections, which are:
 - Rabbit Hill round barrow (List entry no. 1006780); and
 - Ancient sea defence called Roman Bank, 'stretching for 600yds' (550m) NW of Little Dowgate, Wisbech (List entry no. 1006887).
- These are both approximately 3km north of the EfW CHP Facility Site.

Grid Connection

Site

There are no designated heritage assets within the Order limits for the Grid Connection.

Study Area

- Within the 2 km Study Area for the Grid Connection there are (listed in **Appendix 10.A**):
 - 209 listed buildings; and
 - 1 Scheduled monument.
- There are no conservation areas or registered park and gardens, other than those previously noted as within the 2km Study Area for the EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections, and no world heritage sites, registered battlefields, protected wreck sites or protected military sites within the Study Area.

Listed buildings

As with the 2km Study Area for the EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections, many of the listed buildings are within Wisbech town centre. Other listed buildings are located within the historic settlements of Walsoken and Elm.

Scheduled monument

The single scheduled monument located within the 2 km Study Area for the Grid Connection is the Cross in All Saints churchyard (List entry no. 1018313)

4.3 Non-designated heritage records

- These comprise of assets or records identified through other sources listed in **Section 3.3**.
- The HER records identified within the Order limits (listed in **Appendix 10.A**) represent all periods from Palaeolithic to modern and comprise a range of record types including small find locations, historic landscapes, farmsteads, extant monuments, earthworks, buildings, military structures, memorials, telephone boxes, and archaeological sites and deposits.

EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections

There are seven non-designated heritage records recorded within the Order limits for EfW CHP Facility, Access Improvements, TCC and CHP Connection and these



are listed in Table 10B.2 HER records within the Order limits for EfW CHP Facility, Access Improvements, TCC and CHP Connection.

- There are 235 non-designated heritage records within the 1km Study Area for the EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections. One of these is located to the immediate south of the EfW CHP Facility Site and relates to modern and undated features recorded during archaeological evaluation (CHER MCB16839). These features related to a pit, pond, linear features and single undated ditch. The former course of the 19th-20th century March and Wisbech Branch railway also abuts the EfW CHP Facility Site (CHER MCB19612).
- Within the Study Area for the EfW CHP Facility, Access Improvements, TCC and CHP Connection, non-designated records primarily relate to the locations of buildings attested in documentary sources including two 19th century industrial buildings (CHER MCB24082, MCB25696 710m north-east of the EfW CHP Facility Site), six 19th century houses and an inn CHER MCB27469, MCB27470, MCB27471, MCB27472, MCB27473, MCB27474, MCB27475) and a manor house of medieval-19th century date (White Hall, CHER MCB27476). Extant structures are also present in the Study Area for the EfW CHP Facility, Access Improvements, TCC and CHP Connection, in the form of the River Nene navigation (CHER MCB20859) as well as examples of WWII anti-invasion defences including a loopholed wall (CHER MCB29655).

Further to the above, a number of non-designated records relate to features recorded in previous archaeological investigations and unstratified "chance" finds. Four such records are located immediately south-east of the EfW CHP Facility Site and relate to a Roman-dated ditch uncovered during evaluation at the "Potty Plants" site (CHER MCB11045), a scatter of 2nd Century Roman potsherds on New Bridge Lane (CHER MCB5411) and an unstratified sherd of Thetford-ware Saxon period pottery south of New Bridge Lane (CHER MCB5433). Evidence of a post-medieval field system was recorded 390m west of the EfW CHP Facility Site (CHER MCB13906), ditches and gullies of post-medieval date 610m west of the EfW CHP Facility Site (CHER MCB20852), and an assemblage of 1st-4th Century AD Roman pottery 500m west of the EfW CHP Facility Site (CHER MCB9826).

Grid Connection

There are 11 non-designated heritage records recorded within the Grid Connection Order limits and these are listed in **Table 10B.3 HER records within the Grid Connection Proposed Development boundary,** arranged on an approximately south to north order.

There are 237 non-designated heritage records recorded within the Grid Connection Study Area and many of these derive from the collection of surface artefacts, mostly of Roman and Medieval date, and indicating a potential for the presence of associated archaeological remains.

4.4 Aerial photographs

Digital collections held by both the Cambridge University Collection of Aerial Photography and Historic England via Britain from Above were consulted in the preparation of this report. While the available collections were of limited relevance to the project, Aerial Photography formed a significant portion of the data feeding into the Fenland Surveys (Hall 1996, Silvester 1988), which have been incorporated into both CHER and NHER data and referred to in compilation. Observations of roddons (former river channels forming stable land within the silt fens and thus draws for settlement) have been augmented with reference to LiDAR survey (see below).

4.5 LiDAR

LiDAR data of 1m resolution dated to 2020 was obtained from the Environment Agency and projected in Arcmap, assessed in comparison with and against projections of CHER and NHER records. Of chief interest was the location and extent of roddons in relation to the Order limits. One such roddon appears adjacent to the northernmost extent of the proposed Grid Connection, reflected in an NHER record referencing a small scatter of medieval pottery sherds recovered during fieldwalking (NHER MNF19626).

4.6 Previous archaeological investigations

There are two previous archaeological events within the Order limits, and these are listed in **Table 10B.4 Recorded archaeological events within the Order limits.**

Within the Study Area there are a total of 16 HER records relating to previous archaeological desk studies, geophysical survey, trial trenching and excavation (these are listed in a gazetteer in **Appendix 10.A**).

4.7 Site Chronology

EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections

Prehistoric: Lower Palaeolithic (pre-30,000 BP) to Iron Age (700 BC-43 AD)

- No finds or features dating to the Prehistoric periods are known within the Order limits.
- The proximity to the River Nene and historic environmental character as tidal marshland would have served as a periodic resource for human activity, owing to the presence of reliable resources such as reeds, fish and game.
- The Cambridgeshire fenland would have remained an estuarine environment through much of this period, with the area around Wisbech forming part of the "silt" fenland (Hall and Coles 1994). Historically the silt fenland saw more sustained occupation than the peatlands to the south prior to fen drainage works, though the extent to which this can be projected back into prehistory is uncertain as only a few hectares of the pre-Flandrian land surfaces are exposed yielding flints, and other evidence is generally piecemeal. The historic environmental character as tidal marshland would have served as a periodic draw for human activity, owing to the presence of reliable resources such as reeds, fish and game. In addition to this the Roman landscape (described below) with its attendant foci of settlement and activity may have reflected pre-existing landscape exploitation in the later prehistoric periods (Hall 1996) The remains of prehistoric boats were recorded in 1635 during deepening works on the navigable section of the River Nene, 1km north-west of the EfW CHP Facility Site (CHER MCB4730). A flaked flint axe of Neolithic date was recorded at the Station Hotel, 1.7km north of the EfW CHP Facility Site. Iron Age finds have been recorded in the form of two coins 1km north-west of the EfW CHP Facility Site (CHER MCB4760, MCB4761) and a bronze scabbard of similar date 1km north-east (CHER MCB4870). A lack of dry land in the vicinity of Wisbech St Mary during the Iron Age suggests the use of these items as heirlooms in the Romano-British period or association with vessels similar to those described above. No further remains are known in the Study Area.

Romano-British (43 AD – 450 AD)

- No finds or features dating to the Romano-British period are known within the Order limits.
- Finds associated with this period have been recorded within the Order limits, immediately adjacent to the archaeological evaluation at the former Potty Plants site (CHER ECB2062) in 1986 and in 2005 recording a ditch feature of Romano-British date (CHER MCB11045). A monument record relating to a 200-sherd assemblage of 2nd Century pottery with contemporary artefacts and an occupation layer was recorded during works for the Wisbech Bypass (CHER MCB5411). This was associated with a roddon, or raised dried bed of a watercourse, a focus for settlement in fenlands indicating an increased draw for settlement in the area. Fieldwalking on Redmoor Lane, 515m south-west of the EfW CHP Facility Site, recorded around 40 sherds of 1st-4th century Romano-British pottery associated with a roddon system (CHER MCB9826).
- No further finds or features dating to the Romano-British period are known within the Order limits. This period provides the first sustained settlement and industrial evidence within the Wisbech region, principally focused on a network of roddons serving both as settlement locations and a communication network of "trackways" over the silt fen.
- In the earlier excavation on the north side of the bypass recorded potsherds of Roman date in a V-shaped feature. In addition to dyke-side features. While the ditches could not be securely dated the presence of Roman wares was reflected on the south side of the A47. Finds further east along the A47 comprised unstratified Roman pottery (CHER MCB5434) 790m east of the TCC site and a possible occupation horizon under 1.6m of silt observed in a ditch during surveys preceding road construction, 1.4km east of the Order limits (CHER MCB5432).

Early-Medieval and Medieval (450 AD - 1540 AD)

- Medieval period remains within the EfW CHP Facility Site are limited to the chance find of Thetford-ware pottery 340m to the south-east of the EfW CHP Facility site (CHER MCB5433), with no other finds or features dating to the early-medieval or medieval periods known within the Order limits.
- Within the Study Area is the attested location of the Manor House at White Hall (CHER MCB27476) and a moated manor at Barton (CHER MCB19614), 925m north-west of the EfW CHP Facility Site. The centre of activity in Wisbech during this period was commensurate with the modern town centre and the area within the Order limits was likely given over to agriculture.
- The major change to the fenland region during these periods was the construction of sea defences and accumulation of larger permanent settlements around Wisbech itself and smaller villages on a linear plan in the surrounding area, such as Elm.
- The centre of activity in Wisbech during this period was commensurate with the modern town centre and the area within the Order limits was likely given over to agriculture. Just west of the A47/A1101 junction 1.3km east of the TCC site is the purported location of the Elm and Wisbech Leper Hospital (CHER MCB4765). This




hospital reportedly stood at the parish boundary of Elm and Wisbech, with a foundation date of 1378 provided. The purported location is presently occupied by farm buildings and no remains directly relating to the facility are recorded, though substantial remains may survive in the surrounding field, scatters of medieval pottery having been recorded either side of Halfpenny Lane (CHER MCB5434).

Post-medieval and Modern

The archaeological evaluation at Potty Plants in 2005 recorded postmedieval/modern features in the form of a pond, linear feature and pit (CHER MCB16839). This was in addition to an undated ditch. The Order limits is crossed by the former (now dismantled) course of the disused March and Wisbech Railway, established in the 19th century and closed to freight in 2000 (CHER MCB19612). This railway line was reflective of the expansion of Wisbech during the 19th century, major drainage works having been begun in the 17th century ensuring a more stable base for development in the landscape (Hall 1996).

The area covered by the EfW CHP Facility Site was agricultural land on the outskirts of Wisbech until the early 21st century and the land identified for the construction compound remains greenfield.

Modern Disturbance

The construction of the WTS in the footprint of the EfW CHP Facility Site will have removed any archaeological remains to a depth of 0.6m to 2m.

Grid Connection

Prehistoric: Lower Palaeolithic (pre-30,000 BP) to Iron Age (700 BC-43 AD)

The entirety of the Grid Connection route passes through the silt fens region. As with the Study Area around the EfW CHP Facility Site, this carries a potential for earlier prehistoric surfaces to be submerged by silts of Iron Age date (Hall 1978). However, there are no recorded prehistoric remains within the Study Area for the Grid Connection.

Romano-British (43 AD – 450 AD)

- Within the Study Area for the Grid Connection, Romano-British remains are primarily recorded in the form of pottery scatters associated with roddons. Investigations prior to the construction of the Wisbech bypass served to record some evidence for activity along the southernmost extent of the route leading eastward from the EfW CHP Facility Site. A Roman 2nd century pottery assemblage with contemporary artefacts and an occupation layer forming part of a roddon were recorded during works for the Wisbech Bypass (CHER MCB5411). Further east along the A47 a possible occupation horizon was recorded under 1.6m of silt observed in a ditch (CHER MCB5432).
- Several Roman pottery sherds were recovered from the location of a newly-uprooted tree during enabling works for the Wisbech Bypass (NHER MNF19070). Further north along the bypass works an undated burned feature interpreted as a hearth was recorded in addition to several Roman pottery sherds following a surface strip (NHER MNF19650). Further north again, surface stripping recorded undated ditches that contained pottery sherds ranging from the Roman to late medieval period (NHER MNF19214).

Early-Medieval and Medieval (450 AD – 1540 AD)

- The archaeological character of the Grid Connection route during the early medieval and medieval periods is primarily characterised by dispersed rural settlement, agriculture.
- Just west of the A47/A1101 junction is the purported location of the Elm and Wisbech Leper Hospital (CHER MCB4765). This hospital reportedly stood at the parish boundary of Elm and Wisbech, with a foundation date of 1378 provided. The purported location is presently occupied by farm buildings and no remains directly relating to the facility are recorded, though substantial remains may survive in the surrounding field, scatters of medieval pottery having been recorded either side of Halfpenny Lane (CHER MCB5434).
- 4.7.20 Most of the fieldwalking surveys that recorded Roman pottery sherds noted above have also recorded medieval and later pottery remains, indicating continuing settlement and cultivation on the roddons throughout the later medieval period.
- A fieldwalking survey carried out in advance of the Wisbech Bypass (A47) construction recorded a scatter of medieval and post-medieval pottery (NHER

MNF19632). Metal detecting carried out in a field to the south of this investigation recorded medieval and post-medieval coins, in addition to fragments of pottery.

Fieldwalking recorded an undated roddon in addition to Roman, medieval and postmedieval pottery north of Green Lane (NHER MNF18929), with further medieval pottery sherds recorded further north (NHER MNF19037). An archaeological evaluation was carried out on land to the north though only natural features were recorded (NHER ENF95989, MNF43560).

Post-medieval and Modern

Three major post-medieval transport features intersect with the Grid Connection route and these are primarily related to the development of Wisbech and industrialisation in the broader area: The former course of the Wisbech Canal (CHER MCB26862), former Wisbech to Upwell Tramway (CHER MCB25016) and Lynn to Wisbech railway (NHER MNF13596). As in the case of the EfW CHP Facility Site, the major change to the landscape during this period was major drainage works from the 17th century onwards in addition to the parliamentary enclosures. The Grid Connection Corridor was entirely located in farmland during this period prior to the construction of the A47 Wisbech Bypass.

Archaeological potential

5.1 EfW CHP Facility, CHP Connection, Access Improvements, TCC and Water Connections

- The EfW CHP Facility Site includes an existing Waste Transfer Station (WTS) and 5.1.1 an aggregates supply yard, hereafter referred to as the WTS. It is bordered on the western side by the line of the disused March and Wisbech Railway, the route of which is retained as a linear strip of overgrown land. The existing yard was built in the early 2000s, with this area having previously been occupied by pastoral land as part of Great Boleness Field. Historic mapping from the later 19th century shows the area as comprising small regular marked by frequent land drains. From the start of the 20th century it was increasingly used as an area of orchards and market gardens. The TCC is within currently grassed land which has not been previously developed, though part of it may have been used as a construction compound. The CHP Connection element of the proposed EfW CHP Facility runs in an approximate south-west to north orientation beginning from the western boundary of the EfW CHP Facility Site close to the boundary with New Bridge Lane and running to the Nestlé Purina factory in central Wisbech, along the route of the disused March to Wisbech Railway.
- The relatively recent development of an industrial park in this area in the early 21st century resulted in some archaeological investigation within the immediate surroundings of the Order limits. Previous investigation at the Potty Plants site recorded natural clay and peat deposits, in addition to producing structural evidence including ditches, ponds and pits. In the earlier excavation on the north side of the A47 recorded pottery sherds of Roman date in a V-shaped feature, in addition to dyke-side features. While the ditches could not be securely dated the presence of Roman wares was reflected on the south side of the A47. A Roman 2nd century pottery assemblage with contemporary artefacts and an occupation layer forming part of a roddon were recorded during works for the Wisbech Bypass (CHER MCB5411). This could indicate contemporary evidence in the area. Finds further east along the A47 were limited to unstratified Roman pottery (CHER MCB5434) and a possible occupation horizon observe under 1.6m of silt observed in a ditch (CHER MCB5432). Based on the above potential for Roman period remains in the construction compound area is considered medium.
- A review of borehole records from within the EfW CHP Facility Site (Allied Exploration and Geotechnics June 2020) has identified bands of peaty material, which are likely to derive from a freshwater marsh deposit. These interface with deposits of yellow sandy and silty clays, which may be estuarine in origin. These earlier deposits lie directly below modern made ground deposits with a depth of around 0.6m to a maximum of 2m which appear to derive from the construction and use of the WTS.
- There is therefore a medium potential for the presence of sub-surface archaeological of the Roman period within the TCC. This could include evidence for

agricultural or possibly settlement activity. Deposits within the EfW CHP Facility Site have been affected by later development.

5.2 Grid Connection

- For the purpose of describing the known and potential archaeological interests along the proposed Grid Connection route, it has been divided into two sections which are:
 - Southern section, running west to east from the main EfW CHP Facility Site to the A47/A1101 junction, following the A47 on the northern side; and
 - Northern section, running between the A47/A1101 junction and Walsoken Substation off Broadend Road, south to north following the A47 on the northern/western side.

Southern section

- Previous investigation at the Potty Plants site in 1986 (CHER MCB11045) and later in 2005 (CHER ECB2062) recorded natural clay and peat deposits, in addition to producing structural evidence including ditches, ponds and pits. The 1986 excavation was on the north side of the A47, recording sherds of Roman date in a V-shaped feature in addition to dyke-side features. While the ditches could not be securely dated the presence of Roman wares was reflected on the south side of the A47. A Roman 2nd century pottery assemblage with contemporary artefacts and an occupation layer forming part of a roddon were recorded during works for the Wisbech Bypass (CHER MCB5411). This could indicate contemporary evidence in the area. Finds further east along the A47 were limited to unstratified Roman pottery (CHER MCB5434) and a possible occupation horizon observe under 1.6m of silt observed in a ditch (CHER MCB5432). Based on the above potential for Roman period remains associated with agricultural activity to be present in the Study Area is considered to be high.
- Just west of the A47/A1101 junction is the purported location of the Elm and Wisbech Leper Hospital (CHER MCB4765). This hospital reportedly stood at the parish boundary of Elm and Wisbech, with a foundation date of 1378 provided. The purported location is presently occupied by farm buildings and no remains directly relating to the hospital are recorded, though sub surface remains may survive in the surrounding field, scatters of medieval pottery having been recorded either side of Halfpenny Lane (CHER MCB5434). The potential for the presence of remains of the medieval period, including those related to the Leper hospital, is considered to be medium.
- A single sherd of early medieval pottery, Thetford ware was recorded on the south side of New Bridge Street at the western extent of the southern division. This artefact appears to have been unstratified and the potential for the presence of early medieval period remains in this area is considered to be low.
- Two former post-medieval/early modern lengths of transport infrastructure intersect the A1101/A47 junction. These are the former Wisbech Canal (CHER MCB26862), established in the 18th century and the Wisbech-Upwell Tramway (CHER

MCB25016), opened in the 19th century. Both lines were closed and dismantled in the 20th century, and the potential for surviving associated features is considered to be low.

The is therefore a high potential for the presence of sub-surface archaeological remains of Roman date within the Order limits, and a low to medium potential for the presence of medieval and later archaeological remains. Any such archaeological remains could include remains of former agricultural activity, though there is also potential for the presence of remains of Roman period settlement or fragmented remains of the former Wisbech Leper Hospital (CHER MCB4765).

Northern section

- Much of the evidence for the presence of archaeological remains within this section relates to records of surface finds of artefacts recovered in the course of fieldwalking surveys. Much of this was undertaken in the 1980s as part of the Fenland Survey. The Fenland Survey defines the identification of an archaeological site on the basis of surface finds as:
- In field walking, the discovery of a quantity of flints or potsherds, or the recognition of low mounded areas (as low as only 50mm above the level of the field), or the identification of patches of altered soils may signify the presence of some activity in the past. Where the assemblage of flints or sherds appears to be discrete, concentrated in a definable area, then the area is designated a 'site'; a general scatter of finds over a wider area may indicate some ancient activity but is not defined on the ground or in the record as a 'site'. Mounded or embanked areas may be easily recognised, but amorphous shapes alone do not signify a site, as these could be natural features; when associated with domestic or industrial activity, or when earthworks are of a clear shape or formation, e.g., moated, then they are clearly identifiable as 'sites'.
- A fieldwalking survey carried out in advance of the Wisbech Bypass' construction recorded a scatter of medieval and post-medieval pottery (NHER MNF19632). Metal detecting carried out in a field to the south of this investigation recorded medieval and post-medieval coins, in addition to fragments of pottery.
- The above summarised findings within the Grid Connection corridor provide a broad indication of potential in the context of the predominantly enclosed farmland area in which the Grid Connection route is located. This indicates a medium potential for the presence of Roman, medieval and post-medieval archaeological remains. Any such archaeological remains could include remains of former agricultural activity though there is also some suggestion of the presence of remains of Roman period settlement.
