Hi Adam

Thanks for the clarification.

The subsistence fee for SR 2021 No 15 has the charge code 2.16.7. The fee is £4,169. If you still want a bespoke permit, it is the same fee for treatment and transfer of non-hazardous waste from 25,000 up to 75,000 tonnes a year. If 75,000 tonnes is exceeded the subsistence fee is charge code 2.16.6 which is £5,749.

Good afternoon Adam,

Thanks for your email below and for ringing me today. I will respond to your query about subsistence fees as quickly as possible, but before doing so, I need to clarify a couple of things first.

DL 5 – Waste types and tonnages says one of the operator’s proposed waste codes is 19 12 01. This is described as wastes from mineral metalliferous excavation.

However, 19 12 01 should be paper and cardboard. I presume that this is a typo, and the waste type is meant to be paper and cardboard, but please can you confirm this.

However, the Storage of Waste table refers to wood and plastics. These are not included in the list of waste codes. Please can you clarify if the operator does accept, treat and store these waste streams on their site. If they do, please provide the waste codes for them.

The original application under 1.16.12 - Physical treatment of non - hazardous waste and for 1.16.81 - SR 2021 No.15 - mechanical treatment of waste paper,

cardboard and plastic for recovery with fire prevention plan.

There is an obvious change in the application fee, but I cannot find the annual subsistence fee's within the The Environment Agency (Environmental Permitting and Abstraction Licensing) (England) Charging Scheme 2022 Version 1.1 document.

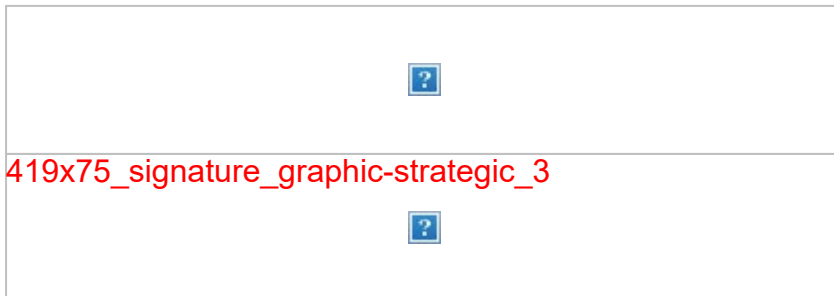

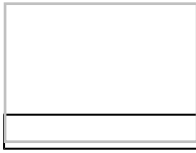
