PE28 3BS, Envar Composting Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

 - S5.4 A(1)(b)(i) Recovery or a mix of recovery and disposal of non-hazardous waste with a capacity exceeding 75 tonnes per day involving biological treatment for composting of waste under aerobic conditions in closed composting reactors or in closed vessels/buildings fitted with appropriate odour abatement to produce a PAS 100 Quality Product output.
 - S5.4 A(1)(b)(i) Recovery or a mix of recovery and disposal of non-hazardous waste with a capacity exceeding 75 tonnes per day involving biological treatment for sanitisation and stabilisation of waste under aerobic conditions in closed composting reactors or in closed vessels/buildings fitted with appropriate odour abatement to produce a compost-like output (CLO)
 - S5.4 A(1)(b)(i) Recovery or a mix of recovery and disposal of non-hazardous waste with a capacity exceeding 75 tonnes per day involving biological treatment for composting of green waste under aerobic conditions in outdoor turned windrows on impermeable surface with a sealed drainage system.
 - Addition of S5.4 A(1)(b)(i) Recovery or a mix of recovery and disposal of non-hazardous waste with a capacity exceeding 75 tonnes per day involving biological treatment for IVC Composting/biodrying of sewage sludge
 - Heat treatment of waste for the purpose of recovery. Heat provided by two biomass boilers, each of a thermal input of 0.9 MWth and two dryers.
 - Treatment and transfer station
 - Addition of wash plant
 - Addition of RDF bale storage
 - Addition of screening, transfer and storage of rag/screenings from wastewater treatment
