# PE3 4BZ, Anglian Water Services Limited environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Anglian Water Services Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/DP3692SL/V004
- Regulated facility type: The facility is currently permitted as a bespoke waste operation and undertakes
  anaerobic digestion of sewage sludge. This substantial variation will change this operation to a bespoke
  installations activity.
  - It will become a Schedule 1 listed activity under the Environmental Permitting (England and Wales)

    Regulations 2016: S5.4 A(1)(b)(i) Recovery or a mix of recovery and disposal of non-hazardous waste with a capacity exceeding 75 tonnes per day (or 100 tonnes per day if the only waste treatment activity is anaerobic digestion) involving biological treatment.
- Regulated facility location: King's Lynn Sludge Treatment Centre, Clockcase Lane, King's Lynn, PE3 4BZ
