**ENRMF Treatment Facility – Environmental Permit EPR/YP3138XB**

Please find enclosed on behalf of Augean South Limited (Augean) an application to vary Environmental Permit number EPR/YP3138XB (the permit) for East Northants Resource Management Facility (ENRMF) Treatment Facility (the site). The changes include an amendment to the individual activity specific tonnage limit for the solidification/stabilisation process, the addition of a proposed new activity comprising neutralisation of hazardous waste and non-hazardous waste and an increase in the maximum temporary storage volume for dredging wastes.

The proposed waste neutralisation process comprises a waste treatment process already authorised and undertaken by Augean at their waste treatment facility at Port Clarence Waste Recovery Park (PC WRP). The proposed waste neutralisation process at ENRMF will be consistent with the process currently undertaken by Augean at PC WRP. The waste neutralisation process hence comprises a process approved previously by the Environment Agency and a process for which Augean have operational experience.

We understand that the application fee of £32,998 has been paid by Augean by electronic transfer (BACS) (Payment reference PSCAPPAUGEAKC2). We have calculated the application fee based on the Environment Agency (Environmental Permitting) (England) Charging Scheme 2019 with reference to the pre-application advice provided by the Environment Agency.

We provide below supplementary information comprising the dates of birth of the Officers of Augean South Limited who are identified on the Company House website. We understand that the Environment Agency may require this information to duly make the application.

In accordance with regulation 48(1)(b) of the Environmental Permitting (England and Wales) Regulations 2016 we request that Appendix B (Process Statement) and Appendix C (R code application examples) of the Technical Description document presented at Appendix F of the application are excluded from the Public Register on the grounds that it is confidential information in the meaning of regulation 51(2). The information included in the Process Statement and in the R code application examples would, if made available on the register, prejudice to an unreasonable degree the commercial interests of Augean. If the documents are read and used by any potential or current competitor and/or customer this may result in a commercial disadvantage to Augean.
