- DIGESTED SLUDGE CAKE IS IMPORTED FOR MATURATION.
- SPILLAGES AND SURFACE RUNOFF WITHIN THE CAKE BAY ARE COLLECTED IN THE SURFACE WATER DRAINAGE SYSTEM WHICH RETURNS TO THE WORKS RETURN PUMPING STATION.
- WASTES FROM SEWER CLEANING OPERATIONS ARE IMPORTED INTO FAIRLEE WTW BY VACTORS. SURPLUS LIQUID IS REMOVED FROM THE VACTOR AND DISCHARGED INTO THE BUNDED "DENATERING" AREA.
- ONCE THE SURPLUS WATER HAS BEEN REMOVED, THE REMAINING SOLID WASTES FROM THE SEWER CLEANING OPERATIONS ARE DEPOSITED INTO THE CORNER OF BAY 5 FOR DRYING.
- GULLY IS CONNECTED TO THE SITE DRAINAGE SYSTEM AND RETURNS TO THE WORKS PUMPING STATION.
