PR2 5BB, 3R Technology UK Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for 3R Technology UK Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/TP3602SH/V004
- Regulated facility type: The site currently accepts hazardous plastic wastes arising from Waste Electrical and Electronic Equipment (WEEE), including materials containing brominated flame retardants (BFRs). These materials contain Persistent Organic Pollutants (POPs).

The operator is proposing the physical treatment of non-hazardous waste to treat non-hazardous plastics, mirroring the existing hazardous treatment process. The proposal also includes the addition of waste codes and the sorting of non-hazardous batteries arising as a by-product of the treatment activities; batteries will not be accepted on site as a standalone waste stream. The application further proposes additional waste codes for the hazardous plastic treatment activities, along with amendments to waste code descriptions.

The operator is also seeking to introduce additional covered waste storage areas.

- Regulated facility location: Unit 21-22 Roman Way, Longridge Road, Preston, PR2 5BB

Providing a business can prove that the proposed activities meets all the legal requirements, including environmental, technological and health requirements, then we are legally obliged to issue a permit, even if some people do not approve of the decision.
