Hi Mrs Latham,

Thank you for your patience and unfortunately I can't duly make the application for now.

There are a few details that we require and are missing from the application:

- 1. Non-Technical Summary:** This should include a summary your operations, a summary of the key technical standards and relevant control measures arising from your risk assessment. I do understand that you wish to increase the site capacity but you also mention a new BTS system. Will this be a separate listed activity from the existing treatment plant?
- 2. Site Plan(s):** You must send us a site plan that identifies all of the land on which your activities and permitted operations take place. The site plan should provide a date and a reference and must be drawn accurately to a defined scale. The outline of the site must be clearly marked. It will be helpful if local features are shown on the plan to help us place the site in its local environment.

From what I can see on p5 in the presentation provided, building 1 and 2 are outside the current site boundary. If this is true, we will require a Site condition report.

3. **Site condition report:** the site condition report (SCR) should be in accordance with H5 guidance and it should build on the SCR that was submitted with the initial permit application/subsequent variations.

4. **Environmental Risk Assessment:** You should describe the environmental risk posed by your activities. This must take the form of an environmental risk assessment which should follow the methodology set out in 'Risk assessments for your environmental permit' at [Risk assessments for your environmental permit - GOV.UK \(www.gov.uk\)](#).

You should consider using our assessment tool to assess your environmental risk. Our assessment tool will inform you when more detailed modelling is required. [Risk assessments for specific activities: environmental permits - GOV.UK \(www.gov.uk\)](#).

Please note that the site is within screening distance of Red Scar and Tun Brook Woods (SSSI).

5. **BAT assessment:** You must demonstrate how you will meet any relevant Best Available Techniques. This should include consideration for any relevant Directives, such as Industrial Emissions Directive.

Please note that we usually give applicants 10 working days to provide additional details needed at the duly making stage, but let me know if you can provide the above details before the 16/03/2022.
