### RG19 4NB, Wastecare Limited: environmental permit consultation

**The aim of this consultation is to ask whether you have any comments relevant to the permit application**

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Wastecare Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/JB3204MH/V002
- Regulated facility type: The proposed variation will authorise a change from the current activity which is an inert waste physical treatment facility to a hazardous and non-hazardous waste household, commercial and industrial transfer facility (installation and waste site).

The scheduled activities will be S5.3A(1)(a)(ii) the repackaging of hazardous waste for recovery and S5.6A(1) (a) Temporary storage of hazardous waste in a facility with a total capacity exceeding 50 tonnes. The waste activities proposed include the storage and treatment of non-hazardous waste.

- Regulated facility location: Colthrop Waste Transfer Station Facility, Unit 1 Colthrop Business Park, Colthrop Lane, Thatcham, Berkshire, RG19 4NB
