Fire plan has been agreed therefore the site has begun operations.

The site is not fully operational yet, they are still building and putting in place the infrastructure on site. Plan to be fully operational in 6-8 months. Only excepting skips 15-20/day.

Site has sealed drainage, that leads to 2 tanks, however they need to install a grill/drain at the entrance to the building where the waste is currently being stored, so that the contaminated water runoff from the dust suppression enters the sealed tanks. This must be done by the 27th April and confirmation sent to ■■■ via pictures as this should have been installed before operations commenced on site as stated within the permit. Failure to meet this deadline will lead to the site being scored.

Surface water is kept separated to the contaminated water as stated in the permit.

Site plan needs to be updated as the one submitted with the application does not fit the current operations on site, this needs to clearly outline the exact proposed position of the weighbridge location and sent to ■■■ as soon as possible.

Plans to install the STP are in place, this will be completed within the 12 month period.

Inert waste stored outside of the building does not need to have sealed drainage, as long as within the permitted area. All other waste excepted on site must be stored within the building where sealed drainage is available.

A schedule of work is required until the site is fully operational to ensure that all infrastructure and procedures are in place when the site is able to open at its full capacity. This schedule must be constantly assessed to ensure it represents work on site and that the EMS/working plan is also updated accordingly. The inspecting officer ■■■■■ must also be copied into the schedule and kept up to date on the progress on site.
