I have visited the site today as I wanted to assess the control procedure in place to manage the odour emissions and if there are any issues with emissions of odours at site. Recently there are a series of odour complaints from the residents of the area and I visited the site to establish whether or not procedures are in place and followed to minimize emissions.

I have met with [REDACTED] who is the [REDACTED].

Today the weather was sunny and warm with a gentle breeze from east.

I have walked around the site with [REDACTED] and I was pleased to see that the yard area is very tidy and well organised. The waste quantities deposited outdoor consists solely of inert materials, which are stored on concreted area. A different part of the yard is now used only to store empty skips.

The northern part of the transfer station building appears tidy and no odour is present there at all. Few waste bays are locate din this part of the building. I have suggested [REDACTED] to keep the quantities of waste under control and he said that the waste in question was getting removed later today.


The southern part of the building is the one were odorous dry plastic fines from Biffa are temporary stored. In the building the odour is very low and the action of a new sprayer is noticeable. The odour from the waste in the building is low and a cleaning products smell almost completely covers it. The amount of flies on the waste is kept to a minimum.

The sprayer used is re-filled with a mix of disinfectant, deodorizer and water and is used constantly during the day. The benefit of having this sprayer in place are evident in the building.

The recommendation I have after my visit is related to the roof:

[REDACTED] explained me the roof was all fixed, however, the action of the wind blown off one tile.

[REDACTED] told me that it will be fixed as soon as possible.
