This includes a description of the site and environmental surrounding at the time.</p> <p>This site condition report has been produced to support the 2022 permit application. The accompanying documents should be found in the permit application folder.</p> <p>The site currently has a EPR permit, Standard Rules 2008 No 19 and is an existing operating site. A SCR was not created for the site as it was not required to issue a SR permit.</p> <p>Refer to various management plans in the application folder; Environmental risk assessment Environmental management plan Odour management plan</p> <p>This is not exhaustive of the measures Anglian Water may take to protect the environment from our activities.</p>

2.0 Condition of the land at permit issue

<p>Environmental setting including:</p> <ul style="list-style-type: none"> • geology • hydrogeology • surface waters 	<p><u>Published Geology – British Geological Survey</u> Desk survey using the British Geological Survey interactive online map shows;</p> <p>The surrounding superficial geology of the site includes clay, silt, sand and peat. Superficial deposits formed up to 2 million years ago in the Quaternary Period. The setting is sedimentary rock which are shallow-marine in origin.</p> <p>The parent bedrock material is shown as Lewes Nodular Chalk Formation, Seaford Chalk Formation and Newhaven Chalk Formation - Chalk. Sedimentary bedrock formed between 93.9 and 72.1 million years ago during the Cretaceous period.</p> <p><u>Hydrogeology</u> The site is not within a groundwater source protection zone.</p> <p><u>Surface Waters</u> A watercourse detailed as 'Bill Meroy Creek' is approximately 160m to the south west of the site at its nearest point and flows in a southerly direction towards the River Thames, which is approximately 360m to the south.</p> <p>Flooding from surface water is shown to be a very low risk to the sites operations as Tilbury WRC. Flooding from rivers and the sea was deemed a very low risk as the site is suitably above sea level. There has never been a flooding event at Tilbury WRC. Tilbury</p> <p>There is low risk of flooding from surface waters and very low risk from sea/rivers, as shown on the EA's long term flood risk calculator.</p> <p>The STC including the storage area is not in Air Quality Management Area.</p>
<p>Pollution history including:</p> <ul style="list-style-type: none"> • pollution incidents that may have affected land • historical land-uses and associated contaminants • any visual/olfactory evidence of existing contamination • evidence of damage to pollution prevention measures 	<p><u>Pollution History</u> The site has not had any pollution incidents.</p> <p>Any pollutions, if any, on the STC have already been shared with the Environment Agency.</p> <p>There have been 8 odour complaints between 2018 and 2022. There were EA non compliance (CAR) forms issued in January 2023 and September 2022 relating to amenity odour related to non functional biofilter.</p> <p>The site has not had pollution incidents.</p> <p>Since April 2023 there have been three notifications of possible odour issues, there were no known issues on site during these periods likely to cause odour. Two of these occasions were considered unlikely to be caused by this treatment works due to the wind direction on that day and the distance from the STW that the odour was observed.</p>

This site has been operating for multiple years. There has been no site investigations as part of this permit application.

Permitted activities	<p>The permitted activities are the import of wastes to the site, and physical/chemical treatment of sludges.</p> <p>These are all permitted under 1 EPR permit: EPR/KP3090VY</p> <p>Details on site assets and locations are included in the main application document in the Application Folder.</p>
Non-permitted activities undertaken	The water recycling centre operates under the urban waste water treatment directive.
Document references for: <ul style="list-style-type: none"> • plan showing activity layout; and • environmental risk assessment. 	<p>“Tilbury Non Technical Summary” in the application folder includes a full description of the site activities and the appendices include site layout.</p> <p>Site plans are also provided as standalone documents in the application folder.</p> <p>The application folder includes the Environmental Risk Assessment and Management Plan.</p>

Have there been any changes to the activity boundary?	<p>The permit boundary on the existing permit is unreadable so a new one has been created for the 2022 permit application.</p> <p>There has been the addition of a dewatered cake silo that receives waste from the dewatering area of the site and stores dewatered cake prior to being loaded into vehicles to be exported from the site.</p> <p>The permit area for this application has been expanded to include the area of the dewatered cake silo and surrounding controlled drainage area.</p> <p>The permitted area has also been reduced as the storage area on the eastern edge of the site has not been used and a partial permit surrender application has been made to remove this area from the permit.</p> <p>Refer to the Tilbury Permit Area 2022 and the surrender application for more information.</p>
Have there been any changes to the permitted activities?	<p>The permitted activities are an existing water recycling centre which carries out physical and chemical treatment of sewage sludges.</p> <p>These are all permitted under 1 EPR permit: EPR/KP3090VY</p> <p>Waste codes 19 02 06 and 16 10 02 have been added to be in line with the Environment Agency's guidance on waste codes for raw cake and domestic waste. The site's activities remain the same.</p>
