# RM18 7NU, Thameside Energy Recovery Facility Limited: environmental permit re-consultation

**The aim of this consultation is to ask whether you have any comments relevant to the permit application**

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Thameside Energy Recovery Facility Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/WP3007LM/V002
- Regulated facility type: 5.1 A(1) b) The incineration of non- hazardous waste in an incineration or co-incineration plant with a capacity exceeding 3 tonnes per hour.

**This is a re-consultation as the operator has now requested to increase the permitted tonnage, from 350,000 to 379,658, as in the original consultation, which opened 17/01/2023 and closed 13/02/2023.**
