#### 1 INTRODUCTION

Sharp Brothers (Skips) Limited is applying to the Environment Agency for an Environmental Permit to carry out the transfer with treatment of non-hazardous waste at the following site:

Botany Way Waste Transfer Station, Beacon Hill Industrial Estate, Botany Way, Purfleet RM19 1SR

The National Grid Reference for the site is TQ55880 78294.

The site is in an industrial estate with other waste and transport activities.

The site is located in Thurrock Council's area.


Sharp Brothers (Skips) Limited has been in operation for over 40 years and operates in neighbouring Havering Council area where it has invested on a state of the art waste recycling facility to provide quality resources and materials to industry for the generation of energy.

The application is for a bespoke environmental permit for 300,000 tonnes per annum throughput.

Sharp Brothers (Skips) Limited operates a fleet of HGVs used to transport construction and demolition and commercial and industrial wastes. The waste will be delivered to the site and processed inside an enclosed building to prepare materials for reuse/recovery/recycling off-site.

With reference to the Environment Agency guidance, it states "If you are applying for a bespoke permit but most of your activities are covered by standard rules, you only need to do a risk assessment for the activities or risks that are not covered by the generic risk assessment for those standard rules."

All of the activities will meet the generic risk assessment for the standard rules. The only risk not covered by the generic risk assessment is the risk to the SSSI. A separate Environmental Risk Assessment has been prepared.



#### 2 THE OPERATOR

Sharp Brothers (Skips) Limited has been operating for over 40 years. The company has an Operating Licence for 60 HGVs. The Operating Centre is at the existing Rainham facility.

Sharp Brothers (Skips) Limited operate a fleet of HGVs used in the collection and transportation of construction, demolition and excavation waste and other commercial and industrial wastes.

The vehicle types are caged vans, skip lorries, rollonoff lorries and bulk transport vehicles. The applicant will import construction, demolition, commercial and industrial wastes to the site for treatment to minimise waste destined for landfill in accordance with the waste hierarchy.

The site will be staffed whenever the site is open by staff with training and operational experience from the Rainham Head Office. The Transport Manager and Technically Competent Person will be based at the site.

Sharp Brothers (Skips) Limited currently employs >70 staff at its Rainham facility and this additional facility will employ a further 25 persons.

The operations will involve initial pre-sorting of certain wastes e.g. metals (metals are unsuitable for the materials processing at the Rainham facility) and clean deliveries of construction waste.

This operation will achieve as close to 100% recycling, ensuring the waste is fully recycled/reused/recovered.

The annual throughput will not exceed 300,000 tonnes per annum.


Figure 1 – Process Flow Diagram




Figure 2 – Schematic of the waste separation and sorting plant being operated at site
