MCP Standard Rules

Based on what you have told us in the application, it is likely that you will be able to apply for one of two Standard Rules permits for the MCP, which would then form part of the bespoke waste operation permit and be covered under the same EPR number.

If the MCP is to run on natural gas, you are likely to be able to apply for <u>SR 2022 number 9</u>. If the MCP is to run on LPG then you are likely to be able to apply for <u>SR2018 number 7</u>. LPG falls under 'Other gaseous fuel' for the purposes of the definitions within SR2018 number 7.

Information on the MCP Standard Rules is here. Here you will also find the SR application form, in Excel format. The Excel application form has a 'rule set helper' tab which you will be able to populate which will confirm which SR is appropriate. Please complete this form and, assuming that you can meet the requirements of either of the Standard Rules, send back to me.

Fees

You have currently paid a total of £11,204, consisting of £7,930 for the waste operation and £1,246 for the assessment of the Odour Management Plan.

If your MCP meets the above requirements, in addition to these fees, we require the MCP Standard Rules application fee, for 1 MCP, of £446 as detailed here.

Odour Management Plan

The submitted Odour Management Plan does not contain the level of detail that would normally be required, however, from initial review it would appear that the site is in a low risk location so an OMP may not be required. This will be looked into in further detail at determination and if an OMP is deemed not to be needed then the £1,246 fee will be returned to you.

Please check that you can meet either of the Standard Rules permits, and if you can, **complete the SR application form and provide the additional fee by 14/05/2024**. If you believe you cannot meet either of the SR permits, please let me know asap.
