RM9 6PU, Stolthaven Dagenham Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Stolthaven Dagenham Limited. Please use the reference number below when making comments on this application.

Permit Number: EPR/WE4467AC/A001

Regulated facility type: This is a new bespoke waste permit application. The site intends to store, steam heat and transfer the below three non-hazardous wastes for recovery. The annual throughput is no more than 300,000 tonnes per annum. No more than 55,000 tonnes of waste to be stored on site at any one time.

* 02 03 04 - Material unsuitable for consumption or processing - acid oil.

* 20 01 08 - Biodegradable kitchen and canteen waste - food waste.

* 20 01 25 - Edible oils and fats – used cooking oil and tallow.
