Following a report regarding run-off from your site Cath Harris met with Anne Young to carry out a site inspection focussing on the activities in the yard, the site drainage and the site boundaries.

The visit followed a period of prolonged rainfall.

Wash down area

Dolavs are washed out in the yard using a high pressure hose. (See photos). The water is directed down the drainage gullies which drain to the effluent treatment.

The run-off from the wash down area must not reach the unmade ground where the wagons drive round to the lairage.

There are also cracks in the hardstanding which must be repaired to prevent groundwater contamination.

Action: I recommend that you refer to the guidance documents https://www.gov.uk/guidance/pollution-prevention-for-businesses and review your drainage plans to make sure that you have a sealed system which does not allow contaminated water to leave the site.

We walked around the site perimeter. There is a metal fence which runs along the site boundary. Runoff from the site is passing through the fence on to the land at the back. (See photos).

Action: Measures must be put in place to prevent this runoff from occurring.

We discussed the planned changes to the site. This will include a new vehicle entrance and a new access road. This will run past the existing office building to a new car park which will be built on the grassed area behind the behind the existing car park.

The surface water will drain to the effluent treatment and therefore additional attenuation will be required.

The planned changes should take account of the actions above. You will also need to up-date your drainage plan and <u>pollution incident response plan</u> which should be incorporated in to your Environmental Management System (EMS).

I agreed to return to site in Spring to review progress.
