Hello,

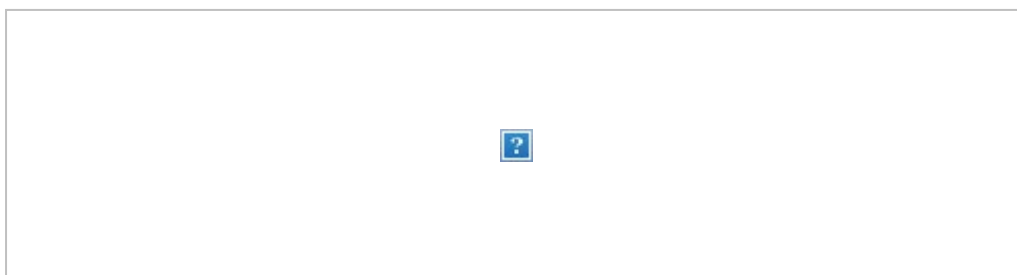
It has come to light that the 8 waste permit applications (detailed below) may not have been received by PSC. I am checking with my ex colleague whether she received a bounce back at the time.

I am pleased to submit eight applications for bespoke physico-chemical waste treatment permits at Blackburn Meadows WwTW, Deighton WwTW, Naburn WwTW, Old Whittington WwTW, Sandall WwTW, Whitby WwTW, Woodhouse Mill WwTW and Hull WwTW.

Payment was made on 05/08/2021, reference number PSCAPPYORKSWI005. This was for a total of £63,440 made up of 8 x application fees of £7,930. Each application document contains the relevant forms: Form A, Form B2 and Form B4. Each document contains a specific F1 form which describes the charges for that site. As these applications have been paid with one total fee and are being submitted as a group, I have also attached an F1 form which covers all 8 sites.
